SEINATE.

Monday, March 23, 1903. Senate met according to adjournment, and was called to order by the President.

Prayer by the Rev. Mr. Tandberg of Gardiner.

Journal of the previous session read and approved.

Papers from the House disposed of in concurrence.

Read and Assigned.

An Act amendatory to An Act passed at this session of the Legislature, relating to superintendent of schools.

On motion by Mr. Gardner of Penobscot, laid on the table.

An Act to amend Section 2 of Chapter 508 of the Private and Special Laws of 1885, as amended by Chapter 134 of the Private and Special Laws of 1887, Chapter 527 of the Private and Special Laws of 1893, and Chapter 425 of the Private and Special Laws of 1901, relating to Norway municipal court.

On motion by Mr. Wing of Androscoggin, this bill was laid on the table.

An Act to incorporate the Peaks Island Water and Light Company. On motion by Mr. Burns of Cumberland, this bill was laid on the table pending the acceptance of the report.

Orders.

On motion by Mr. Goodwin of Somerset, it was, Ordered, that the secretary of the Senate be, and he hereby is requested and authorized to compile from the Senate journal, and any other authentic source, notes of rulings on the rules of the Senate and notes of rulings on the joint rules in form similar to notes of rulings on the rules of the Senate of the commonwealth of Massachusetts; and report the same to the next Legislature; the expense and compensation of said secretary to be paid by the Governor and Council from the appropriation for the contingent expenses of the Legislature.

On motion by Mr. Clark of Hancock, it was, Ordered, that the justices of the supreme judicial court are hereby requested to give to the Senate, according to the provisions of the constitution in this behalf, their opinions on the Public Laws of 1887, as amended by

following questions: 1. Is so much of the Public Law of Maine for 1895, Section 1, Chapter 18, constitutional, that reads as follows: "In case of loss under this policy, and a failure of the parties to agree as to the amount of loss, it is mutually agreed that the the amount of such loss shall be referred to three disinterested men,-the company and the insured each choosing one out of three persons to he named by the other, and the third being selected by the two so chosen. The award in writing by a majority of the referees shall be conclusive and final upon the parties as to the amount of loss or damage; and such reference unless waived by the parties shall be a condition precedent to the right of action in law or equity to recover for such loss, but no person shall be chosen or act as a referee against the objections of either party who has acted in a like capacity within four months. No suit or action against this company for the recovery of any claim by virtue of this policy shall be sustained in any court of law or equity in this State unless commenced within two years from the time the loss occurred."

2. Is Section 1, Chapter 18 of the Public Laws of 1895 constitutional?

Mr. Goodwin of Somerset, presented resolve in favor of clerk for the committee on revision of the Statutes, and the same was referred to the committee on appropriations and financial affairs.

An Act relating to prize logs on the **P**enobscot river and its tributaries.

An Act to incorporate the Madunkeunk Dam and Improvement Company.

An Act to incorporate the Duck Lake Dam Company.

An Act to incorporate the Kibble Dam Company.

An Act to limit the number of fish that may be taken from Spring lake in Somerset county in one day.

An Act fixing the beginning of the open season for fishing in Little Sebago pond, in the towns of Gray and Windham in Cumberland county.

An Act to repeal so much of Chapter 30 of the Revised Statutes, as amended by Chapter 42, Section 5, of the Public

Laws of 1899, as prohibits fishing in Parlin stream, in Somerset county from the mouth of Bean brook to Long pond.

An Act to repeal so much of Chapter 30 of the Revised Statutes, as amended by Section 5 of Cnapter 42 of the Public Laws of 1899, and as amended by Chapter 379 of the Private and Special Laws of 1901, as prohibits fishing through the ice in Big Carry pond, or West Carry pond, so called, in Somerset county.

An Act to repeal so much of Chapter 30 of the Revised Statutes, as amended by Section 5 of Chapter 42 of the Public Laws of 1899, and as amended by Chapter 329 of the Private and Special Laws of 1901, as prohibits ice fishing in Black, Whittier and Perry ponds, in the towns of Vienna and Chesterville, in Kennebec and Franklin counties.

An Act to repeal so much of Chapter 30 of the Revised Statutes, as amended by Section 5 of Chapter 42 of the Public Laws of 1899, and as amended by Chapter 230 of the Private and Special Laws of 1901, as prohibits fishing through the ice in Large Greenwood pond in Elliottsville and Willimantic, in Piscataquis county.

An Act to prohibit the sale of any kind of fish, except eels, taken from certain ponds in Kennebec and Somerset counties.

An Act to prohibit fishing in Morrill pond in the county of Somerset.

An Act to prevent the destruction of smelts or tomcods, so called, in Steuben bay.

An Act to amend Section 1 of Chapter 516 of the Private and Special Laws of 1897, entitled "An Act additional relating to the appointment of a recorder for the Bath municipal court."

An Act relating to compensation of county commissioners of Hancock county.

Resolve abating a part of the State tax of the town of Bowdoinham for the years 1903 and 1904.

An Act to prohibit the taking of clams in the shores or flats within the town of Scarboro.

Papers from the Senate disposed of in concurrence.

Resolve in favor of the Maine Insane Hospital, was referred to the committee on appropriations and financial affairs under a suspension of the rules in concurrence with the Senate.

Resolve in favor of Albion Oakes. secretary of the committee on ways and bridges, was read twice and passed to be engrossed under a suspension of the rules in concurrence with the Senate.

Report of the committee on ways and bridges, reporting ought to pass, on resolve making an appropriation for the ownership and maintenance of State and county bridges, came from the Senate, the resolve indefinitely postponed pending the acceptance of the report.

On motion of Mr. Clarke of Nobleboro, the resolve was indefinitely postponed in concurrence with the Senate.

Senate Bills on First Reading.

An Act to amend Section 6 of Chapter 267 of the Public Laws of 1893, entitled, An Act to provide for the printing and distribution of ballots at the public expense, and to regulate voting at State and city elections, came from the Senate amended by Senate amendment A.
