SENATE.

Friday, February 10, 1905. Senate called to order by the President

Prayer by Rev. Mr. McKinnon of Augusta.

Journal of yesterday read and approved.

Papers from the House disposed of in concurrence.

Mr. IRVING of Aroostook: Mr. President: I will say that this bill was reported back to this Senate last Tuesday at the request of the Senator from Knox, and also, indirectly at the request of the senator from Cumberland and the Senator from Waldo; and it was assigned for today. Now they are all present, and we should like very much to discuss it and its merits this morning. If the senator from Knox is ill and requests a re-assignment for next Tuesday and not later than that. we may not object. The three senators are here at this moment,; and might be here next Monday; but we insist upon our rights as members of the committee on Appropriations and Financial Affiairs and it seems to me it is carrying senatorial courtesy too far to ask repeated continuances of this matter, after having assigned it for this morning. Mr. MORSE: Mr. President: This is a matter in which there is considerable interest manifested outside of the Senate members. This home for the feebleminded children of the State is a matter that has pretty wide discussion. I was not aware that it was to come up this morning until I came into the Senate charaber. While I have been engaged on this committee for two years, and have been trying to find out the needs and wants of this particular matter, I would like to have opportunity to go over the subject carefully, so that T might be able to give some senator who may not have taken so much interest in it as " have, some new ideas in relation to it. While we may not be able to arrive at any conclusion which would be beneficial to their wants at this time. still it is ground that it would be well for us to look over, and which must be more thoroughly examined when the time comes. I would be glad to have it assigned for Tuesday if I had not already made arrangements to go to Bangor to visit the Insane Hospital there. The PRESIDENT: The Chair will, at this time state to the Senate that, in private, he has tendered to the Senator from Knox the Chairmanship of that Committee, and that senator has stated his inability to accept the same on account of public duties. Is the Chair correct?

Mr. Staples: That is right, Mr. President.

The President thereupon appointed on said Committee, Messrs. Curtis of Cumberland, Plummer of Androscoggin, and Allen of York, on the part of the Senate.

The PRESIDENT: The Chair wishes to state to the Senate that Senator Plummer of Androscoggin who was appointed by the Chair, yesterday, as one of the Committee to attend the funeral services this afternoon of Hon. Joseph H. Manley, is unavoidably detained from attending, and unable to perform his duties upon that committee, and therefore wishes the Senate to excuse him.

The Senate thereupon voted that Mr. Plummer be excused from said committee.

Mr. STAPLES: Mr. President: I thank you for the courtesy of the appointment, but I am obliged to go to Bangor, this afternon, and shall be unable to attend the funeral of our friend, ex-Senator Manley. If I am in order, I would suggest in my stead the name of Senator Philoon of Androscoggin.

Senator Staples was thereupon excused by vote of the Senate from serving upon said committee; and senator Philoon of Androscoggin was appointed a member of said committee. The President announced the committee on the part of the House.

On motion by Mr. Sturgis of Cumberland, the Senate adjourned to meet on Monday, February 13, 1905 at 4.30 e'clock in the afternoon.
