On further motion by Mr. McKenney these bills were tabled for printing pending reference to a committee.

On motion of Mr. Gleason of Mexico the rules were suspended and that gentleman introduced a bill, An Act tto further provide for nominating candidates for political parties, and on further motion by Mr. Gleason the bill was tabled for printing pending reference to a committee.

The House order providing for a joint special committee on salaries and fees, came from the Senate, that branch appointing on its part Messrs. Sewall of Sagadahoc, Staples of Knox and Page of Somerset, to which committee the House joins Messrs. Milliken of Island Falls, Peacock of Lubec, Reynolds of Winslow, Skidmore of Liberty, Newbert of Augusta, Giddings of Gorham and Stevens of Portage Lake.

On motion of Mr. Milliken of Island Falls the report of the special committee with accompanying bill relating to free transportation was taken from the table, and on further motion by the same gentleman it was referred to the committee on salaries and fees.

SENATE.

Friday, Jan. 11, 1907.

Senate called to order by the President.

Prayer by the Rev. Mr. Evans of Augusta.

Journal of the previous session read and approved.

Papers of the House disposed of in concurrence.

The President announced that the House has joined on the specail committee on salaries and fees, the following members: Milliken of Island Falls, Peacock of Lubec, Reynolds of Winslow, Skidmore of Livermore, Newbert of Augusta, Giddings of Gorham, Stevens of Portage Lake.

The following bills, petitions, etc., were presented and referred:

Judiciary.

By Mr. Philoon of Androscoggin: Bill, An Act to amend Section 29, Chapter 93 of Revised Statutes relating to liens on buildings and lots, wharves and piers. Referred to committee on judiciary.

By Mr. Libby of Waldo: Bill, An Act to amend Chapter 212 of the Private and Special Laws of 1903, as amended by Chapter 139, by the Private and Special Laws of 1905, relating to the Searsport Water Co. and the Stockton Springs Water Co.

By Mr. Deasy of Hancock: Bill, An Act granting certain Powers to the Mount Desert Transit Co.

Legal Affairs.

By Mr. Sewall of Sagadahoc: Petition of the Municipal officers of the city of Bath, the county commissioners of Sagadahoc, and others for maintenance by the State of all patients committed to the Insane hospital of the State, now maintained at the expense of the towns and cities.

Banks and Banking.

By Mr. Philoon of Androscoggin: An Act to extend the charter of the Merchants Trust Co. and change the name of some of the corporations.

Pensions.

By Mr. Philoon of Androscoggin: Resolve in favor of John D. Bubier.

solve in favor of Bath Military and Naval Orphan Asylum.

Also resolve for an appropriation to encourage the utilization of tidal power for commercial purposes in the State of Maine.

Inland Fish and Game.

By Mr. Deasy of Hancock: Petition of L. F. Giles and 31 others, residents of Hancock county, praying that Section 3 of Chapter 407 of the Private and Special Laws of 1903 be so amended that it shall be unlawful to fish for. catch or kill any trout in any of the waters lying wholly or partly in the county of Hancock, for sale, or to directly or indirectly sell any trout in said county of Hancock.

Orders.

On motion of Mr. Putnam of Aroostook, it was Ordered the House concurring that when the Senate and House adjourned, to meet on Monday. the 14th day of January, 1907, at 4.30 o'clock P. M.

The foregoing order was sent down for concurrence and was later returned concurred in by the House.

On motion of Mr. Putnam of Aroostook it was, Ordered, that on Tuesday next, January 15, the Senate shall proceed to vote for a senator for Congress for a full term from March 4. 1907, in accordance with the laws of the United States.

On motion by Mr. Barrow of Penobscot it was Ordered. The House concurring, that a list of the committee of this Legislature, together with the order of proceedings and rules of each branch, and the joint rules, be printed in pamphlet form, 300 copies for the use of the Senate, 600 copies for the use of the House.

On motion of Mr. Reardon of Kennebec it was ordered. That the seat in the Senate occupied by John B. Reardon be declared vacant and that George W. Heselton of Gardiner be declared

elected a senator for the county of Kennebec.

Mr. REARDON of Kennebec: Appropriations and Financial Affairs. President and members of the Senate, By Mr. Sewall of Sagadaboc: Re- I would like to say a word regarding the foregoing order. I wish to say that I thank the committee on Senatorial votes for their very fair, impartial and painstaking recount in this election contest, and I wish to say further that, in my sincere judgment, the verdict which has been rendered in this case is a fair and impartial verdict. With Senator Heselton's permission, I would like to ask, as a last favor, this morning, that I have the honor of tendering him his seat. (Applause)

> On motion of Mr. Stearns of Penobscot, it was Ordered, that the pay of John B. Reardon as a member of the Senate, be made up to the end of the session, with mileage, and that he may be allowed the further sum of \$100 for expenses attendant upon the contest as to his seat in the Senate.
