SENATE.

Friday, February 1, 1907.

Senate called to order by the President.

Prayer by Rev. Mr. Clifford of Gardiner.

Journal of the previous session read and approved.

On motion by Mr. Stearns of Penobscot the Order relating to the State Liquor Agency which came from the House read and passed in that branch, was laid on the table.

On motion by Mr. Mills of Hancock the Senate non-concurred with the House, in referring to the Committee on Legal Affairs, Bill, "An Act to amend Chapter 64 of the Private and Special Laws of 1899 as further amended," relating to the Wilson Stream Dam Company; and on further motion by the same senator the Bill was referred to the Committee on Interior Waters.

Papers from the House disposed of in concurrence.

On motion by Mr. Putnam of Aroostook it was Ordered, the House concurring, that when the Senate and House adjourn, they adjourn to meet on Tuesday the fifth day of February, 1907, at eleven o'clock, A. M.

The foregoing order was subsequently returned from the House concurred in by that branch.

By Mr. Sewall of Sagadahoc: Bill, "An Act to incorporate the Sagadahoe Trust Company."

By Mr. Parkhurst of Penobscot: Bill, "An Act to change the name of Widows' Island, Penobscot Bay."

By Mr. Theriault of Aroostook: 'Bill, "An Act to set off parts of lots numbered 304, 305 and 206, situated in Hamlin and annex the same to town of Van Buren."

By Mr. Wyman of Washington: Petition of Fred J. Leighton and two selectmen of town of Steuben, to set the road leading from Marsh Road to Fred

J. Leighton's residence off from town of Steuben to town of Milbridge.

By Mr. Theriault of Aroostook: Petition of Selectmen of town of Van Buren and Assessors of Hamlin plantation that so much of lots Nos. 304 and 305, and part of lots numbered 306 as lie in Hamlin Plantation may be cut off and annexed to the town of Van Buren.

By Mr. Houston of Piscataquis: Remonstrance against the Resubmission of the Prohibition Law by S. A. Buzzell and 63 others of Parkman.

Mr. Sewall of Sagadahoc presented the following Resolve: "Resolve with reference to Rebate of Railroads."

Resolved, That the rebate of taxes granted by Railroads by former Legislatures, without regard to party, to aid in the industrial and commercial development of the State ought not, on principles of equity and in justice to contracting parties and innocent purchasers be disturbed but it is the sense of this body that such rebates should neither be newly granted nor extended in any manner that would be construed as an exemption from taxation." The same senator moved that the foregoing Resolve be tabled for printing pending its adoption, and reserved the right to table the Resolve after it should be printed.

Reports of Committees.

By Mr. Brown for the Committee on Agriculture to which was referred the Bill, entitled "An Act to amend Section 33 of Chapter 39 of the Revised Statutes and Section 7 of Chapter 68 of the Public Laws of 1905," have had the same under consideration and report that same ought to pass.

By Mr. Deasy for the Committee on Judiciary to which was referred the Bill, entitled "An Act to enable citizens to assess taxes for Street Sprinkling" have had the same under consideration, and report that the same be printed and recommitted.

By Mr. Deasy for the Committee on Judiciary to which was referred the Bill, entitled "An Act to grant certain powers to the Mount Desert Transit Company" have had the same under consideration and ask leave to report the same in a new draft under same title and that it ought to pass.

By Mr. Mills for the Committee on Legal Affairs to which was referred the Bill entitled "An Act to amend Section 9 of Chapter 139 of the Revised Statutes relating to Extradition Papers have had the same under consideration and ask leave to report the same under new draft under same title and that it ought to pass."

Mr. Simpson for the Committee on Appropriations and Financial Affairs, on Official Bond of the State Treasurer Elect for the years 1907 and 1908, recommend that the same be approved and placed on file in the office of the Sceretary of State. The report was accepted and the bond approved by vote of the Senate.

The Committee on Legal Affairs on Bill, "An Act to create an lien on the manufacture of Staves and Laths, reported same in new draft under same litle and that it ought to pass.

The Committee on Railroad and Expresses on Bill, "An Act to extend the charter of the Hancock County Railway Company." reported same in new draft under title of 'An Act in relation to the Mount Desert Railroad Company and the Mount Desert Transit Company;" and that same ought to pass.

The same Committee on Bill, "An Act

to extend the charter of the Houlton and Danforth Electric Railway Comoany," reported that same ought to pass.

The same Committee on Bill, "An Act to extend the charter of the Houlton and Woodstock Electric Railway Company," reported that same ought to pass.

The Committee on Appropriations and Financial Affairs on Resolve in favor of Bath Military and Naval Orphan Asylum, reported that same ought to pass.

The same Committee on report of the Committee appointed to examine the accounts of the State Treasurer of the year 1906, reported that same be placed on file.
