### SENATE.

Thursday, February 21, 1907. Senate called to order by the President.

Prayer by Rev. Fr. Hamel of Augusta.

Journal of the previous session read and approved.

Papers from the House disposed of in concurrence.

On motion by Mr. Curtis of Cumberland, Bill, "An Act to amend Chapter 73 of the Private and Special Laws of 1905, entitled, 'An Act to authorize the sale of bonds on the installment plan by a foreign corporation,'" was tabled to be printed, pending reference.

On motion by Mr. Parkhurst of Penobscot, Bill, "An Act to amend Chapter 419 of the Private and Special Laws of 1897, and Chapter 155 of the Private and Special Laws of 1899 and Chapter 308 of the Private and Special Laws of 1901 entitled, 'An Act to incorporate the Penobscot East Branch Log Driving Company." was tabled for printing, pending reference.

On further motion by the same Senator, Bill, "An Act to incorporate the Penobscot Log Driving and Improvement Company," was tabled for printing, pending reference.

On motion by the same Senator, Bill, "An Act to incorporate the Maine Title and Guaranty Company," was tabled to be printed, pending reference.

Bill, "An Act to provide for the ownership and maintenance of highway bridges by the State in the several counties, came from the House having been reported by the Committee Ways and Bridges," submitting same in new draft under same title and that it ought to pass and amended by House amendment A. Report accepted and Bill read once. Mr. Simpson of York offered Senate amendment A amend the Bill by adding after the word "length" in the fourth line of Section 4 the words "constructed and in process of construction, including those bridge districts." Mr. HESELTON of Kennebec: Mr. President, by special request I introduced yesterday, in the absence of the senator from Hancock, Senator Mills, "Resolve relating to the calling of a convention to propose an amendment of the Constitution of the United States for the prevention of polygamy." At the time of introducing it I did not realize to what committee it should referred. After the consultation with the President of the Senate, I believed the proper committee to which it should be referred is the committee on Legal Affairs; and I therefore move its reference to the committee on Legal Affairs.

At the suggestion of Senator Mills of Hancock the Resolve was read in full and adopted without reference to a committee.

The Resolve is as follows:

#### STATE OF MAINE.

Resolve relating to the calling of a convention to propose an amendment of the Constitution of the United States for the prevention of polygamy.

"Whereas, it appears from investigation recently made by the Senate of the United States, and otherwise, that polygamy still exists in certain places in the United States notwithstanding prohibitory statutes enacted by the several states thereof, and

"Whereas, The practice of polygamy is generally condemed by the people of the United States and there is a demand for the more effectual prohibition thereof by placing the subject under Federal jurisdiction and control. at the same time reserving to each state the right to make and enforce its laws relating to marriage and divorce; now, therefore,

"Resolved. That the application be made and hereby is made to Congress. under the provisions of Article V. of the Constitution of the United States for the calling of a convention to propose an amendment to the Constitution of the United States whereby polygamy and polygamous cohabitation shall be prohibited, and Congress shall be given power to enforce such prohibition by appropriate legislation.

"Resolved, That the Legislature of all other States of the United States now in session or when next convened. be and they hereby are respectfully requested to join in this application by the adoption of this or an equivalent resolution.

"Resolved further, That the Secre-

rected to transmit copies of this application to Senate and House of Representatives of the United States, and to the several members of said bodies representing this State therein; also to transmit copies thereof to the Legislatures of all other states of the United States."

On motion by Mr. Deasy it was Ordered, That the committee on Judiciary be directed to enquire into the expediency of amending Revised Statutes, Chapter 135, Section 12, relating to challenge of jurors in certain criminal cases whereby the number of challenges allowed to the state may be increased, and report by bill or otherwise.

The same senator for same committee on Bill, An Act to change the time of holding the January session of the court of county commissioners for Hancock county, reported that same ought to pass.

The same senator for the same committee on Bill, An Act to incorporate the Penobscot Bay Electric Company, reported same in new draft under same title and that it ought to pass.

Bill, An Act to make valid the organization of the Middle Intervale Telephone Company, and to legalize its acts and doings reported the same ought to pass.

Mr. Clarke for the committee on legal affairs on Bill, An Act to prevent desertion and non-support of families, reported same ought to pass.

The same senator for the same committe on Bill, An Act to amend Chapter 123 of the Public Laws of 1905 entitled "An Act for the protection of children," reported that same ought to pass.

Mr. Page for the committee on appropriations and financial affairs, on Order of the Legislature relating to advisibility of requiring clerks in State treasurer's office to give bond of some surety company in place of bond signed by individual, reported Resolve entitled "Resolve for payment of premium on bonds of clerks in State treasurer's office."

Mr. Eaton for the same committee on Resolve in favor of the Maine State Sanatorium Association, reported same in new draft under same title, and that it ought to pass.

Mr. Page for the same committee on Bill, An Act to provide for the care and education of feeble-minded children and Resolve entitled "Resolve in aid of the Maine Home and School for Feeble Minded Children," referred from the last Legislature; also Bill entitled "An Act to provide for the care and education of the feeble minded children," presented at this session, and that portion of the Governor's message relating to the subject; reported Bill in new draft under title of "An Act to provide for the care and education of the feeble minded" and that it ought to pass.

The foregoing reports were accepted and the several bills and resolves were tabled for printing under the joint rules.

Mr. Houston for the committee on taxation on Bill, "An Act relating to the taxation of railroads and street railways, reported that same ought not to pass.

Mr. Simpson for the committee on appropriations and financial affairs on Resolve in favor of the town of Mariaville, reported that same be re-

ferred to the committee on ways and bridges.

Mr. Curtis for the committee on publib buildings and grounds on resolve in favor of the town of Isle au Haut, reported that same be referred to committee on State lands and State roads.

Mr. Tartre for the committee on railroads and expresses on Bill, An Act authorizing the construction of the Eastern Electric Railway Co., reported that same ought not to pass.

Mr. Mills from the committee on legal affairs on Bill. An Act to amend Section 19 of Chapter 6 of the Revised Statutes relating to elections, reported that legislation thereon is inexpedient.

Mr. Deasy for the committee on judiciary on Bill, An Act to amend Chapter 40 of the Revised Statutes relating to the fortnightly payment of wages, reported that same ought not to pass. Which reports were severally accepted.
