SENATE.

Monday, Feb. 25, 1907.

Senate called to order by the President.

Prayer by Rev. Mr. Kearney of Augusta.

Journal of the previous session read and approved.

Papers from the House disposed of in concurrence.

Bill, An Act to authorize and empower the city of Old Town to own, maintain and operate a lighting, heating and power plant. This bill came from the House referred to the committee on legal affairs.

Mr. PUTNAM of Aroostook: Mr. President. At this time I wish to object to the reception of that bill by the Senate, and, if necessary, to move that the Senate non-concur with the House in its action in receiving that bill. Early in this session the Senate passed an order limiting the time for the reception of private and special legislation to Feb. 19. One week before that time expired the Senate voted unanimously not to extenl that time. All parties in the State had six weeks' notice that private and special legislation was not to be introduced after Feb. 19, and I must say that if we wish to conclude our labors here by April 1, it will be necessary to adhere to that order as passed, and not let the bars down to admit private and special legislation. I have here a letter from our former secretary of Stare, the Hon. Nicholas Fessenden, with which he encloses a bill for private and special legislation, and in which he asks me to introduce this bill under suspension of the rules. and to have it passed. I shall return it to him, telling him that it is impossible to comply with his request, as this Senate and House have passed this order limiting the time for the reception of private and special legislation to Feb. 19. and that we will not let down the bars and let in a flood of private and special legislation.

I hope the Senate will not admit this bill passed by the House and sent down here for concurrence.

Mr. STAPLES of Knox: Mr. President. I heartily concur with the senator and 37 others; of Joseph Rand and 13

from Aroostook in regard to this matter. We have very much and very important legislation which will take us to the last week in March, if we have nothing more. I, too, have received, in the last few days a number of important bills from citizens of this State, who asked me to introduce them. I have replied that I could not do it because the Senate had concluded not to receive any private and special legislaconcur tion after Feb. 19. I heartily with the senator from Aroostook. I think we have all we can attend to. I hope the Senate, by a unanimous vote, will set down on this bill and stop any more private legislation. I want everybody to have their rights, but it seems to me there has been time enough to present private and special legislation.

On motion by Senator Putnam of Aroostook the bill was indefinitely postponed.

Mr. Deasy for the committee on judiciary on Bill, "An Act to amend Chapter 94 of the Private and Special Laws of 1903, entitled 'An Act to prevent the pollution of the waters of Sebago lake,' " submitted same in new draft under same title and that it ought to pass.

The same senator for the same committee on Bill, "An Act in relation to the Frontier Steamboat Co." reported that the same ought to pass.

Mr. Page for the committee on appropriations and financial affairs, on "Resolve for an appropriation for carrying on the work for the State Survey Commission," reported that the same ought to pass.

Mr. Rice for the committee on inland fisheries and game, on petition of A. C. Vanner and others of Washington, for a close time on trout fishing in Branch stream and Hersey brook, situated in said Washington in Knox county, submitted Bill, An Act to regulate fishing in Branch stream and Hersey brook in the town of Washington in county of Knox, and that the same ought to pass.

The same senator for the same committee, on petition of John Chadwick and others of Rangeley and vicinity, for a law to regulate fishing in the Richardson and Beaver ponds in the county of Oxford, submitted Bill, "An Act to regulate fishing in the two west Richardson ponds, the two east Richardson ponds and the two Beaver ponds in the county of Oxford," and that it ought to pass.

The same senator for the same comassigns, to erect, construct and main- mittee, on petition of J. S. Allen and

others, for a law to prevent the putting of sawdust and other mill waste into Bear river, Oxford county, submitted Bill. "An Act to prohibit the throwing of sawdust and other mill waste into Bear river, or any of its tributaries, lying within the towns of Newry and Grafton in the county of Oxford," and that the same ought to pass.

The foregoing reports were accepted and the several bills and resolves were tabled for printing under joint rules.

Majority and minority reports of the committee on temperance on "Resolve for an amendment to the Constitution by abrogating and annulling Article 26, being the amendment to the Constitution adopted on the 8th day of September, in the year of Our Lord 1884, relating to the sale and manufacture of intoxicating liquor, and being the fifth amendment to the amended Constitution" were submitted. The majority report that the same ought Mills. not to pass, signed Hastings, Perkins, Waldron, Irving, Dow, Libby. The minority report, that the same ought to pass signed Brown, Newbert. Pooler. On motion by Mr. Staples of Knox said reports were tabled and Thursday, Feb. 28, assigned for their consideration.

On motion by Mr. Heselton of Kennebec the report of insurance commissioner on matter covered by the order of January 28, 1907, was taken from the table and on his further motion was referred to the committee on salaries, together with the accompanying communication.

On motion of Mr. Garcelon of Androscoggin the Senate adjourned.
