SENATE.

Tuesday, March 5, 1907.

Senate called to order by the President. Prayer by Rev. Mr. Doherty of Au-

gusta.

Journal of the previous session read and approved.

Papers from the House disposed of in concurrence.

Bill, An Act to amend the law in relation to the taking of smelts in the St. Croix river. On motion by Mr. Wyman of Washington this bill was indefinitely postponed.

Petition for law to prevent prize fighting. Previously referred by the Senate to the committee on legal affairs was returned from the House the same being ordered placed on file by that branch. The Senate voted to recede and to concur with the House.

An Act to grant certain powers to the Northeast Harbor Water Company. This bill passed to be engrossed by the Senate on Feb. 25, was returned from the House passed as amended by House Amendment A. The Senate voted to reconsider the vote whereby the bill was passed to be engrossed. House amendment A was adopted in concurrence and the bill as amended was passed to be engrossed.

and that the same ought to pass signed by Messrs. Curtis, Clarke, Pike, Snow and Haskell; Report B being that legislation thereon is inexpedient signed by Messrs. Barrows, Allen, Danforth, Lynch, Farrar. On motion by Mr. Clarke of Lincoln both reports were tabled to be printed pending the acceptance of either report and Wednesday, March 13 assigned for their consideration.
