SENATE.

Senate called to order by the President.

Prayer by Rev. Mr. McCombe of Hallowell.

Journal of the previous session read and approved.

in concurrence.

On motion by Mr. Simpson of York "Resolve for appropriation of \$5000 to be expended by the treasurer and trustees at the Insane hospital at Augusta and to increase the wages of employes in and about said hospital" was tabled.

House Bills Read and Assigned.

An Act relating to the perfecting of record of titles to real estate, was read and assigned.

Bill, An Act to provide for the ownership and maintenance of highway bridges by the State in the several counties, which was indefinitely postponed by the Senate; and by the House passed to be engrossed as amended by House amendment A was returned to the Senate, the House insisting on its action and asking for a committee of On motion of Mr. Park conference. hurst of Penobscot the Senate voted to insist and to join the committee of conference. The President stated that he would later announce the committee of conference on the part of the Senate.

Bill. An Act to incorporate the Winter Harbor and Eastern Railway Company, which was passed to be engrossed on Feb. 8, was returned from the House by that branch passed to be engrossed as amended by House amendment A. On motion by Mr. Irving of Aroostook the bill and amendment were tabled.

The majority and minority reports of the committee on shore fisheries on Bill, "An Act for the better protection of shore fishing within the town of Yarmouth in the county of Cumberland" were submitted. The majority being that the same ought not to pass signed Messrs. Wyman, Foss, Simpson, Baldwin, Peacock, Thomas, Hibbard, Farnham, Herrick. The minority report being that the same ought to pass signed Mr. Oram. In the House

the minority report was substituted for the majority report and the bill as amended by House amendment A was passed to be engrossed. On motion by Mr. Sewall of Sagadahoc the reports were tabled and Wednesday March 13 assigned for their consideration .

The committee of conference on the Papers from the House disposed of . matter of the disagreeing action of the two Houses on the Sebago lake bench mark reported that the committee are unable to agree. The report itself, ought not to pass, which was accepted by concurrence in the House, also was returned to the Senate. The committee were discharged.

> Mr. PARKHURST-Mr. President, I desire to say regarding this amendment for the information of the Senate and in explanation of its purpose that the resolve in question makes the usual appropropriation for the Penobscot tribe of Indians and while it provides for the return to them of their interest funds and shore rentals, the habit has been to pass a portion of it on the shore rentals and interest to some specific objects. The committee in preparing their reports, actacting in accordance with past usage, apportioned one thousand dollars from the shore rentals, which belonged to the Indians alone, for medicinal attendance. It is their desire that a portion should be taken from the shore rentals and a

portion from the interest fund and the amendment does not disturb the amount of the appropriation, but simply arranges for its distribution.
