SENATE.

Tuesday, March 12, 1907.

Senate called to order by the President.

Prayer by Rev. Mr. Herrick of Hallowell.

Journal of the previous session read and approved.

Papers from the House disposed of in concurrence.

House Bills Read and Assigned.

An Act to amend Section 41, 42 and 43 of Chapter 15 of the Revised Statutes, relating to district superintendents of schools.

An Act authorizing the Island Ferry Company to construct a wharf and ferry slip into the waters of Casco Bay.

An Act to authorize the town of Van Buren to issue bonds

An Act to amend chapter 48 of the Revised Statutes relating to savings banks.

An Act to incorporate the Paris Trust Company. (On motion of Mr. Hastings of Oxford the bill took its second reading under suspension of the rules and was passed to be engrossed.)

An Act to change the name of the Boothbay Harbor Banking Company to the Boothbay Harbor Trust Company and to ratify certain doings in relation thereto.

An Act to extend the open season for hunting the game bird known as goldeneye or whistler in the county of Hancock.

An Act to regulate fishing in Allen Brook, so-called, and its tributaries in the town of Exeter, county of Penobscot.

Resolve in favor of Juno F. Curtis.

An Act to extend the charter of the Mount Desert Trust Company, which was passed to be engrossed by the Senate on March 7, 1907, was returned from the House, in that branch passed to be engrossed as amended by House amendment A. (On motion by Mr. Deasy of Hancock this bill was tabled.) Tabled pending reconsideration of its passage to be engrossed.

(On motion by Mr. Merrill of Cumberland the report was tabled, pending the acceptance of the same).

The same senator for the same committee on bill. "An Act to reappeal the charter of the Madawaska Log Driving Company." reported that the same ought not to pass.

The same senator for the same committee, on bill, "An Act to repeal the charter of the Pond's Sheer Boom Company, and all acts amendatory thereto," reported that the same ought not to pass.

Mr. Irving from the committee on Banks and Banking, on report of the Bank Examiner for the year of 1906, reported that the same be accepted and placed on file.

Mr. Wyman from the committee on Shore Fisheries, on remonstrance of G. D. Gray and others, against any change in the present law extending the close time on clams from the 15th of September to the 1st day of January, reported that the same be placed on file.

The same senator for the same committee, on report of the Commissioners of Sea and Shore Fisheries for the years of 1905 and 1906, reported that the same be accepted and placed on file.

Mr. Deasy for the committee on Judiciary, on bill "An Act to incorporate

the Kittery Water District, within the limits of the town of Kittery, for the purpose of supplying the inhabitants of said district, likewise the remaining portion of said town, with pure water for domestic and municipal purposes." reported that the same ought to pass.

Mr. Hastings for the same committee, on bill, "An Act regulating the time of service of fire department of the city of Portland," reported that the same ought to pass.

Mr. Philoon for the committee on Education on "Resolve in favor of Freedem Academy," submitted the same in new draft under the same fille.

Mr. Rice for the committee on Inland Fisheries and Game, on bill "An Act to regulate the taking of white perch in Lake Sebasticook, in the town of Newport, county of Penobscot, and in its tributaries," with retitions of the selectmen and others, also petition of J. M. Sanborn and 28 others for the same, submitting the same in new draft under the same title.

Orders of the Day.

On motion by Mr. Irving of Aroostook House Document No. 350 "An Act to incorporate the North Jay Trust Company" which was finally passed at yesterday's session was recalled from the Governor.

The President subsequently announced that the bill had been returned from the Governor, Senator Irving thereon offered Senate amendment A and moved that the bill and amendment be tabled and that Thursday, March 14th be assigned for its consideration. The motion prevailed. The bill and amendment were tabled pending reconsideration of the passage of the bill to be enacted.

On motion by Mr. Heselton of Kennebec the special assignment for today namely, the substitution of the bill for the report of the committee on Mercantile Affairs and Insurance "ought not to pass," on Bill, An Act to establish a law uniform with other states relative to insurance policies" was taken from the table, and on his further motion was re-tabled and assigned for Wednesday, March 20th.

Senator Irving of Aroostook offered Senate amendment A and pending adoption of same the bill and amendment were tabled for printing.
