On motion of Mr. Davis of Yarmouth the house reconsidered the vote whereby it concurred with the Senate in referring to the Portland delegation, bill, An Act to amend the charter of the city of Portland, and on further motion by the same gentleman the bill was tabled for printing.

A communication was received from the secretary of State transmitting the returns of the votes given in by the several cities, towns and plantations in the State on the 14th of September last for Representatives to the Legislature, and on motion of Mr. Hall of Caribou it was referred to the committee on elections.

On motion of Mr. Hall of Caribou,

Ordered, Whereas Friday the 12th of February 1909 is the centennial anniversary of the birth of one of the grandest characters in American history, Abraham Lincoln, held in reverent memory of all lovers of freedom and liberty of every clime; and whereas the day will be fittingly observed in thousands of schools and public bodies throughout this broad land of ours and may with appropriateness be honored by the State of Maine at its capital city; therefore be it

Ordered, The Senate concurring, that suitable public exercises be held in the hall of the House of Representatives or other place to be selected by the committee, on the evening of February 12, 1909, and that a joint committee consisting of seven on the part of the House with such as the Senate may join be named to make all necessary arrangements.

Mr. Montgomery of Camden announced that he had performed the duty assigned him yesterday of conducting Mr. Stover, Representative-elect from Brunswick, to the Governor and Council, and that Mr. Stover had taken and subscribed the oaths necessary to qualify him to enter upon the discharge of his official duttes.

Mr. Trimble of Calais announced that Mr. Campbell of Cherryfield had taken and subscribed the oaths necessary to qualify him to enter upon the discharge of his official duties.

Mr. Tibbetts of Orrington announced that Mr. Trickey of Corinna, Mr. Buswell of Stetson and Mr. Campbell of Kingman had taken and subscribed the oaths necessary to qualify them to enter upon the discharge of their official duties.

Mr. Clark of Hollis announced that Mr. Whitehouse of Dayton had taken and subscribed the oaths necessary to qualify him to enter upon the discharge of his official duties.

#### Orders of the Day.

Mr. Davies of Yarmouth moved that the vote be reconsidered whereby the House voted to concur with the Senate in the passage of the order directing the committee on appropriations and financial affairs to consider the advisability of requiring a reasonable fee from persons or corporations asking for private and special legislation.

The SPEAKER: The original order is in the possession of the Senate. The House can request its return.

On motion of Mr. Davies a message was sent to the Senate requesting that the order be returned.

On motion of Mr. Davies the vote was reconsidered whereby the House concurred with the Senate in the passage of the order.

Mr. Davies moved that the House non-concur with the Senate in its reference of the order to the committee on appropriation and financial affairs.

Mr. BIGELOW of Portland: Mr. Speaker, I would like to have the gentleman from Yarmouth explain why he thinks the House should non-concur on that order.

DAVIES: Mr. Speaker, institutions. If the committee favorably on its passage would be, from my paid a tax or fee by every corporation or by every individual who comes and asks for private or special laws. This Legislature is supposed to be a tribunal of all the people. There has never been any restriction proposed until the present time upon any one who might come here and ask for the passage of any bill or any resolve or any order, no matter how poor or how rich he might be; and it seems to me that it commits the State to an entirely new and different policy. Tn the past we have been satisfied to grant to all, proper consideration of what might be proposed, and, if it seemed best, to give the legislation a passage; and for my part I can see no reason why the matter should be considered in the committee looking toward a report for the passage of a bill on a proposition of that sort.

Mr. BIGELOW of Portland: Mr. like to inquire Speaker, I would through the Chair or of the gentleman from Yarmouth if it is not true that Legislatures of the past have been passing countless bills. private and special laws for corporations and at great expense to the State, and if it is not true that there probably will be many bills of the sort this year and succeeding years, and that they have a tendency to delay the consideration of public laws and greatly prolong the sessions of the LegIslature?
