Mr. Hall from same committee reported same on Resolve in a new draft, Resolve for the providing of testimonials for the honorably discharged soldiers and sailors who volunteered for Maine for service in the Civil War.

Mr. Libby from the committee on salaries and fees reported same on bill in a new draft, An Act to increase the salary of the judge of the superior court for Kennebec county.

Mr. Porter from same committee reported same on bill in a new draft, An Act to amend and correct a clerical error in Chapter 84 of the Public Laws of 1905 relating to the compensation of the clerk to the commissioners of inland fisheries and game.

Mr. Dorr from the committee ways and bridges, on petition reported bill, An Act to authorize the town of Harpswell to construct and maintain a bridge from Great island in said Harpswell to Hen Island on which Fred E. Darling now lives.

Mr. Colby from the committee on forestry and water supply reported same on bill, An Act authorizing the Governor to issue his proclamation to prevent the use of firearms in the forests during a dangerously dry time.

Mr. Bemis from the committee on agriculture reported same on bill, An Act to appropriate moneys for the protection of trees and shrubs from the introduction and ravages of dangerous insects and disease.

The reports were accepted and the bills and resolves ordered printed under joint rules.

Messrs. Hastings, Looney, Baxter, Peters, Hersey, Andrews, Burleigh and of bonds, was taken from the table,

Wing, a majority of the committee on judiciary, reported "ought not to pass' on Resolve proposing an amendment te the Constitution for the election of secretary of State, treasurer and attorney general by the qualified electors of the State.

Messrs. Davies and Montgomery, a minority of same committee, reported "ought to pass" on same.

On motion of Mr. Davies of mouth both reports were tabled and assigned for consideration for tomorrow morning.

On motion of Mr. Burieigh of Augusta, Resolve providing for the payment of claims, accounts and demands against the State accrued during the year 1908 on account of deficiency in appropriation for the prevention and extinguishment of forest fires, was taken from the table.

Mr. Burleigh offered House Amendment A by inserting after the title the following preamble: "Whereas. various deficiency items comprised in Resolve are long overdue and further delay in the payment thereof will occasion great inconvenience to the forestry department of the State government and the citizens of the State, and whereas in the opinion of this Legislature these facts constitute this resolve an emergency measure which is immediately necessary for the preservation of the public peace. health or safety, now therefore said Resolve is amended by adding at the end thereof the following paragraph. 'In view of the emergency set forth in the preamble this Resolve shall take effect when approved."

Mr. BURLEIGH of Augusta: Mr. Speaker: Under the provisions of the new constitutional amendment with reference to the initiative and referendum no acts or resolves except emergency matters shall take effect until 90 days after the adjournment of the Legislature; and as this particular resolve seems evidently to fall within the class of emergency matters, the object of this amendment is that it may take effect at once.

The question being on the adoption of the amendment, the amendment was adopted.

Mr. MARSHALL of Portland: Mr. Speaker, I arise to ask if it is not necessary that it should be passed by a two-thirds vote and that a roll call or its equivalent should not be taken?

The SPEAKER: The Chair understands

The SPEAKER: The Chair understands that upon the final passage of a resolve, or upon the passage to be enacted of a bill, the record must show that two-thirds of all the members elected to the House voted in its favor. That vote, as the Chair understands it, may be taken upon the final passage of a resolve or upon the passage to be enacted of a bill.

The resolve was then read the second time and was passed to be engrossed as amended.
