An Act to extend the provisions of Chapter 241 of the Private and Special Laws of 1907, entitled "An Act to supply the town of Lisbon with pure water," came from the Senate with Senate Amendment A, by striking out Section 2, "This Act shall take effect when approved."

On motion of Mr. Hersey of Houlton the vote was reconsidered whereby the bill was passed to be engrossed, Senate Amendment A was adopted and the bill was then passed to be engrossed as amended in concurrence.

An Act to ratify, confirm and make valid the organization of the Andover Water Co. and authorize it to issue bonds and extend its plant, came from the Senate with Senate Amendment A, by striking out Section 10, "This Act shall take effect when approved."
