There is legislation before the Senate covering the subject matter of these private bills, and it seems to me proper that we should defer the consideration of this until that is decided.

I can see no reason why the House should not take it up today and dispose of it on its merits and have it out of the way and not get it mixed up with other matters and have the thing delayed along so that a little later we expended in some other manner than in won't know where we are at. > Mr. ROUNDS of Portland: Mr. Speaker, I hope the House will discuss this matter at the present time. This is a little town and it cannot afford, and the county cannot afford, to build this bridge, and we all know that Millinocket and East Millinocket are growing very fast. I understand that the county will not build it and it is a matter for the State to appropriate the money.

> Mr. BEYER of Portland: Mr. Speaker, I happen to have been up in that territory and I know something about the condition and needs of this bridge. I am heartily in favor of it. This is a special locality where they cannot build it themselves and it is one of those cases where it is right and proper that the State should appropriate money for that bridge. I certainly hope that this resolve will receive consideration at the present time.

Mr. PIKE: Mr. Speaker. I shall detain the House but a few moments in setting forth my reasons for moving the indefinite postponement of this resolve. This is a resolve carrying an appropriation of \$20,000. It is for the construction of a bridge from the little town of Medway having a population of 247 and a valuation of \$100,000; and in view of the fact that the schedule of appropriations already before us amounts to nearly \$11,000,000 it seems to me that the expenditure of \$20,000 at this time is not proper. Where are we to stop? Are we to grant every appropriation that people ask for who came in here? It seems to me that we must draw the line somewhere. There is no urgent necessity for the construction of this bridge at this time. It is up there in the wilderness of northern Penobscot county; and I believe that a \$20,000 appropriation can be much better before us appropriations for charitable therefore I hope that the motion of the institutions and for many other matters gentleman from Eastport will not prevail. which are a great deal more pressing than the construction of this bridge; and I ask you, gentlemen, in the interests of economy, to vote for the indefinite postponement of this resolve.

ROBBINS of Fort Kent: Mr. Mr. Speaker, I desire to say just a word as I am one of the committee on ways and bridges. I think I voice the sentiment of every member of that committee when I say that this is one of the fairest and most needed propositions which have been considered before that committee. I see no reason for its indefinite postponement.

Mr. ROUNDS of Portland: Mr. Speaker, you will see on the back of this resolve a statement of facts. This was brought to our attention in conferring upon this matter. The town of Medway, as the gentleman from Eastport says, is up there in the northern part of Penobscot county, a town with not a large population or much valuation, but it is asking us to build a bridge for them so they can get into the town of Millinocket and can market their produce where they have a large market. The town of Millinocket would like to have this bridge. And this appropriation asked for is not for the whole construction. This county and the towns surrounding have got to put in about dollar for dollar in order to get this bridge there. Now the towns of Millinocket and East Millinocket are growing very fast, growing in populatioi and in valuation, but the little town of Medway is standing still; and as I understand it the town of Millinocket is going to help to build this bridge, otherwise it could not be built. Take it home to yourselves, if you were on one side of the river and the ice was going out and you wanted to get across. I think the people of Millinocket and the people of Medway would like to cross that river, and I think that you, gentlemen, if you happened to be up there would like to do the same thing. When the ice is going out or when the logs are running it is very dangerous to cross. For about four months of the year it is all a man's life is worth to attempt to cross on this ferry. No more worthy a case has been brought before the committee on ways and bridges than this; That has been and must be considered

Mr. PETERS of Ellsworth: Mr. Speaker, I have no personal interest in this matter nor am I a member of the committee which reported the resolve, but I cannot help feeling that from the standpoint of the State there are considerations here which should move us to grant the sum asked for by the resolve. As I understand it, it is not alone one town on one side of this river and one or two on the other that are to be benefited by the proposition, but from the evidence accompanying the resolve there are 11 or 12 towns, plantations and other organizations on one side of the river and a very rapidly growing community on the other, and on account of the present conditions there are no reasonable facilities for communication between these country towns on one side of the river and the rapidly growing manufacturing communities on the other; consequently these farming communities, some 12 towns and plantations, are unreasonably impeded in getting there products to market. There is no bridge over the river. There is a ferry. At times it is impossible to use the ferry. There is ice running in the river at times and there are logs at times and there are conditions of the water and the weather which at times render it impossible to get across at all. Now if the policy of the State is ever to aid local communities in the matter of better facilities of communication it seems to me this is a case where we should act, it seems to me entirely wise and proper to render aid in this case to this community.

It is a very easy thing to raise the cry of economy, but it seems to me that this is one of the things which is entitled to our aid as much as the other matters; it is one of the things we should provide for as well as for the hospitals and the other institutions of the State; it is as important that our large communities like this should have reasonable facilities of communication as it is that our unfortunates should be taken care of; and I see no reason advanced here, nor has any been suggested, why the report of the committee on this matter should not be adopted. The matter of the size of the appropriation we cannot know about.

Mr. DORR of Dresden: Mr. Speaker. the gentleman from Eastport in giving the number of population of the town of Medway quoted the year 1900 when the population was 297 according to the Maine Register. There is no later population given in this book, but you will notice that the polls in 1900 were 107 and in 1904 they were 143. Evidently there has been quite an increase in population during the past nine years. At our public hearing, at which time we thoroughly investigated this matter, those appearing there claimed that there was a population there now of 600 people; and evidently this is far more deserving now than it this State should take hold and help would have been in the year 1900. I hope you will give them this aid to build this bridge.

Mr. BEARCE of Eddington: Mr. Speaker: I feel it my duty to appear on this question for the farmers.
