Papers from the Senate disposed of in concurrence.

Senate Bills on First Reading.

An Act to extend the charter of the Waterville and Winslow Bridge Company.

An Act to provide for the preservation of the records and history of the Grand Army of the Republic, Department of Maine.

An Act to incorporate the Androscoggin Reservoir Company and to authorize it to construct, acquire and maintain a reservoir or storage basin on the Magalloway river at or near the head of Aziscoos Falls in Plantation in the county of Oxford for the purpose of maintaining a more constant flow of water in the Magalloway and Androscoggin rivers, for use for power and manufacturing purposes.

An Act to increase the salary of the warden of the Maine State prison.

An Act to amend Section 115 of Chapter 15 of the Revised Statutes relating to public schools. (Senate Amendments A and B adopted in concurrence.)

An Act to amend Chapter 8 of the Revised Statutes relating to the board of State assessors. (Senate Amendment A adopted in concurrence.)

An Act to incorporate the Sandy Stream Dam and Improvement Company, came from the Senate with House Amendment A rejected.

On motion of Mr. Burleigh of Augusta the votes were reconsidered whereby this bill was passed to be enacted and passed to be engrossed, and on further motion by Mr. Burleigh the House receded and concurred with the Senate in its rejection of the amendment.

The bill was then passed to be engrossed in concurrence.
