#### SENATE.

Thursday, Jan. 28, 1909.

Senate called to order by the President.

Prayer by the Rev. Mr. Herrick of Hallowell.

Journal of previous session read and approved.

Papers from the House disposed of in concurrence.

Bill, "An Act to require life preservers on motor boats" came from the House, by that branch referred to the tabled for printing, pending reference.

Chapter 15 of the Revised Statutes relating to the purchase of second-hand for schools" came from the House, by that branch referred to the Committee on Education. On motion by Mr. Howes of Somerset this bill was tabled for printing, pending reference.

Bill, "An Act to provide for the uniform grading, packing and branding of apples" came from the House, by that branch referred to the committee on Agriculture. On motion by Mr. Howes of Somerset, this bill was tabled for printing, pending reference.

Bill. "An Act to amend Chapter 117 of the Laws of 1905 relating to salaries of County Commissioners of Washington County" came from the House, by that branch referred to the committee on Salaries and Fees. On motion by Mr. Wyman of Washington, the Senate non-concurred with such reference, and on further motion by the same senator the bill was referred to the Washington County Delegation. Subsequently on motion by the same senator, the vote whereby the bill was referred to the Washington County Delegation, was reconsidered, and, on further motion by the same senator, the bill was referred to the committee on Salaries and Fees, in concurrence.

#### House Bill Read and Assigned.

An Act relating to Canning Machinery and Supplies Association. House Amendment A adopted in concurrence.

The following communication was received:

"Augusta, Jan. 28, 1909. To the Honorable Senate and House of

Representatives:

I have the honor to respectfully call your attention to the fact that President Roosevelt has recommended that February 12th, 1909, the 100th anniversary of the birth of Abraham Lincoln, be observed as a National Holiday. Similar action has already been taken by several of the State legislatures. I suggest therefore that it would be particularly appropriate for our Legislature at this time to set apart the committee on Judiciary. On motion of 12th day of February next as a State Mr. Baxter of Cumberland, the bill was Holiday in commemoration of the birth of our lamented ex-President; and I Bill, "An Act to amend Section 19 of trust that the matter may have your favorable consideration.

#### Reports of Committees.

Mr. Hastings for the committee on judiciary, on Bill, An Act in amendment of Sec. 1 of Chap. 136 relating to sentence in criminal cases, reported that same be referred to the committee on temperance.

Mr. Eaton for the committee on appropriations and financial affairs on order relating to the advisability of requiring a reasonable fee from persons and corporations asking for private and special legislation, except educational and charitable institutions, pensions and similar matters, reported the same without recommendation, having been discharged from consideration by a subsequent order.

Mr. Wyman for the committee on sea and shore fisheries, on Bill, "An Act to amend Sec. 3 of Chapter 41, R. S., 1903, relating to sea and shore fisheries, reported that the same be printed and recommitted.

Mr. Walker, for the committee on libra-

ry, on order, That the State librarian appoint a suitable person as reference librarian," reported same ought not to pass.

The foregoing reports were accepted.

Mr. Gowell, for the committee on legal affairs, on Bill, "An Act to protect benevolent, humane, fraternal or charitable corporations or organizations in the use of their names and emblems and providing penalties for the violation thereof," reported same in new draft under title of "An Act to protect benevolent, humane, fraternal or charitable corporations or organizations in the use of their names and emblems, and providing penalties for the violation thereof."

Mr. Osgood, for the committee on appropriations and financial affairs, on resolve in favor of the Maine Home for Friendless Boys, reported that same ought to pass.

The same senator for the same committee, on "Resolve in favor of the Children's hospital," submitted the same in new draft, under same title.

Mr. Mullen, for the committee on railroads and expresses, on Bill, "An Act to extend the charter of the Aroostook Valley Railroad Company," reported that the same ought to pass.

Mr. Emery, for the same committee, on Bill, "An Act relating to the extension of the Fryeburg Horse Railroad," reported that the same ought to pass.

The foregoing reports were accepted, and the several bills and resolves were tabled for printing, under the joint rules.

Mr. STAPLES of Knox: Mr. President, I did intend, at this time, to ask the indefinite postponement of that bill, but owing to the short time that seems to be ahead for the bill I do not care to put any sorrows upon it in its declining few days that it will live in the Legislature of Maine. It has been here so long that everybody knows that dissolution is about to take place. I do not care to have that happen in the Senate of Maine. I therefore move that it be referred to the committee on railroads and expresses, in concurrence. The motion prevailed.
