SENATE.

Wednesday, Feb. 3, 1909. Senate called to order by the President.

Prayer by Rev. Mr. Livingston of Augusta.

Journal of the previous session read and approved.

Papers from the House disposed of in concurrence.

"An Act for the more equitable assessment of taxes on real and personal property" came from the House, by that branch referred to the committee on Taxation. On motion by Mr. Milliken of Aroostook, this bill was tabled for printing, pending reference.

Mr. HASTINGS: Mr. President: In view of the fact that there appeared in one of the evening papers a statement relative to my reasons for tabling this Resolve, which statement was a very fair and accurate one, but one which might be construed as a reflection in some quarters, it seems not inappropriate for me to state to the members of the Senate more fully my reasons for so doing.

Information had come to me from reliable sources that the special appropriation for needy persons for the past two years had been diverted into other purposes by those having the institution in charge, and I was requested to look into the matter before the Resolve came along. It came along unexpectedly yesterday morning before I had opportunity to do that; and I tabled it for that reason. Now, I am happy to say, this morning, after looking into the matter carefully, that this appropriation has not been diverted and that every cent of it for the past two years has been used for needed purposes, and, in addition to that. large sums of money given by private individuals to the institution, have

the Deaf. On motion by Mr. Looney of been used for that purpose. I think, possibly, this rumor gained credence from the fact that so many applications are made to the institution for admittance by needy persons, and the sum appropriated for that purpose is so small that it came about. I went over the matter carefully with Dr. Young, who is secretary of the association-secretary of the State Board of Health, and he gave me a detailed statement of items, names of individuals who had been assisted, and the amount baid for each individual. Now, any senator may have access to that same statement, or any other person, whether a friend to the institution or critic, and I now move, Mr. President, that the Resolve take its second reading.
