Mr. STAPLES of Knox: Mr. President: I very much regret that I feel, at this time, called upon to make an amendment to the bill passed the other day. I regret very much that this Senate curtailed the rights of towns Mr. President: I object to that amendin the matter of the poll tax of each ment for lots of reasons. All over the and every town in this State. This is State of Maine there are, today, yil-

1907, in relation to the appointment of principle. I have seen, from year to year, the rights of towns and of the people being curtailed. A town has not much left when you take this matter away from them. We have seen our highways passing under the control of outsiders. We have seen our schools taken away from the people and placed in the hands of other parties. I am a great believer in home government. I believe that every town and every state should manage its own affairs in its own way. Now, it was passed the other day, and became a law, to have uniformity of taxation in this State. If this bill passes there is only one thing for me to do for my people, and to place myself right before the taxpayers of the State of Maine.

> I want to be understood that, if the right is to be taken away from towns. where every town may vote one dollar or five dollars, according to the condition of the town, then I say, there is only one thing left for me to do, in my position, and from my standpoint; and that is to introduce an amendment. If you must have a uniform tax, let us have it at two dollars all over the State, instead of three dollars. We forget, oftentimes, the poor man. 1 have heard the remark made the last few days that three dollars is all he paid. If he hires your house, or my house, why he has got to pay the tax on that. The man who owns the house puts so much more rent upon it. according to what the taxes are; and the man who owns not a dollar's worth of it pays the three dollars, besides his rent. For that reason, believing that two dollars is sufficient, in this State, in our condition, I offer, Mr. President, this amendment: Senate Amendment A to Senate Doc. No. 64, "Amend by striking out the word "three" in the third line, and inserting Instead thereof, the word "two," etc., and I move the adoption of the amendment.
