SENATE.

Tuesday, February, 16, 1909. Senate called to order by the President.

Prayer by Rev. Mr. Hayden of Gardiner.

Journal of the previous session read and approved.

Papers from the House disposed of in concurrence.

Mr. MULLEN of Penobscot: Mr President: I have the pleasure to notify the Senate that Senator Francis W. Hill of the Tenth Senatorial District, is in attendance and ready to take his oath of office.

The PRESIDENT: The Senate is glad to welcome Senator Hill to his seat. The Chair appoints Senator Mullen of Penobscot to escort Senator Hill to the Council Chamber where he may take the qualifying oath.

Senator Mullen thereupon escorted Senator Hill to the Council Chamber and subsequently reported that Senator Hill had taken and subscribed his oath of office.

The following order came from the House, passed by that branch:

ORDERED, the Senate concurring, that the time for the reception of petitions and bills for private and special legislation be extended to Tuesday. February 23d, 1909, and that all such petitions and bills presented after that date be referred to the next Legislature; and that the Secretary of the Senate cause copies of this order to be printed in all daily papers in the State until February 20, 1909.

Mr. OSGOOD of Androscoggin: Mr. President, I move that the Senate nonconcur in the passage of that order. I believe we have sufficient legislation already upon our books. We enact too much, instead of too little, and I hope that the order will not prevail.

Mr. SHAW of Kennebec: Mr. President, it has always been the custom, to extend the time and not to cut it off arbitrarily; and I think, in fairness to all interested, that it might be well to extend the time a few days. There are that there are a number of important some important matters that members matters, which would come under the no doubt will like to introduce; and I head of private and special legislation. hope the motion of the Senator from which members of the other branch Anderscoggin will not prevail.

Mr. MILLIKEN of Aroostook, Mr. President, I would like to inquire of the Chair, whether under the present order matters dropped into the box this afternoon will be considered?

The PRESIDENT: It was so stated. yesterday.

Mr. MILLIKEN: It seems to me, Mr. President, in view of that fact, and that the interests of justice may be served for all who have special matters to be introduced, that they may still get these matters into the box, in some form, this afternoon. I do not wish by any means to pose as one who wishes to cut off any Senator or Representative from introducing any meritorious matter: but this rule has been passed and notice has been fully given. It is true as the Senator has said that it has been the custom to extend the time in the past; but those here who were present at the last session will recollect that the rule was adhered to. and that introduction of special legislation after that date was resisted. It seems to me, if the rules are to amount to anything and we are to have any limit in this matter, the motion of the Senator from Androscoggin should preyail.

The vote being taken upon the motion of Senator Osgood of Androscoggin, that the Senate non-concur with the House in the passage of the order. 16 Senators voted in the affirmative and 6 in the negative. So the motion prevailed.

Subsequently, on motion by Milliken of Aroostook, the Senate reconsidered the vote whereby it noncon-curred with the House in the passage of the foregoing order:

Mr. MILLIKEN or Aroostook: Mr. President, I now move the adoption of the following amendment to the order, namely: By striking out the words "Tuesday, February 23" and substituting the words "Thursday, February

Mr. OSGOOD of Androscoggin: Mr. President, I made the original motion this morning, and after the explanation offered just now by the Senator from Arcostook, I very heartily accept

Mr. HASTINGS of Oxford: Mr. President, there has been some misunderstanding that the Secretary of the Senate will not have time to get this notice to the people if this amendment is made, because of the fact that the amendment will have to go before the House to be acted upon tomorrow, which would be the 17th, so that notice could not be gotten into the paper before the 18th. I am very sure the Senator from Aroostook is always disposed to be fair, and I am; but it does not seem that this is quite late enough. It seems to me it ought to be extended to Monday, or the first of the week. I have not any bills going in.

Mr. MILLIKEN: Mr. President, I will say that the other branch, in my judgment, is keen enough about the matter so that they will be glad to vote upon it today; and the date. Thursday, was decided upon, after consultation, as satisfactory to them. No notice is required to the Public because the Representatives in the various cases know what these matters are, but simply have not been able to put them into shape.

Mr. HASTINGS: Mr. President, I have no personal objection; but I desire to call the attention of the Chair
