SENATE.

Thursday, Feb. 18, 1909.

Senate called to order by the President.

Prayer by Rev. Mr. Hope of Augusta.

Journal of previous session read and approved.

Papers from the House disposed of in concurrence.

On motion by Mr. Hastings of Oxford, it was—Ordered, the House concurring, that when the Senate and House adjourn, they adjourn to meet on Friday, February 19, at 9 o'clock in the forenoon.

Subsequently this order was returned from the House, that Branch concurring in its passage.

Bill, "An Act to amend Chapter 4 of the Revised Statutes relating to the better protection of sheep." This bill came from the House, by that Branch referred to the committee on Agriculture. On motion by Mr. Howes of Somerset, the same was tabled for printing pending reference.

"Resolve in favor of a memorial statute and tablet to Lincoln." This Resolve came from the House, by that Branch passed to be engrossed without reference to a Committee.. Under suspension of the rules, the resolve was passed, took its two several readings in the Senate and was passed to be engrossed.

Bill, "An Act to confirm and make valid the organization of the Andover Water Company and authorize it to issue bonds and expand its plant," having been passed to be engrossed by the Senate, as amended by Senate Amendment A, was returned from the House, that Branch having adopted House Amendment A and Amendment A in concurrence. motion by Mr. Milliken of Aroostook, the vote whereby the Act was passed to be engrossed in the Senate was reconsidered and on his further motion, House Amendment A was adopted in concurrence and the bill as amended

Mr. WYMAN of Washington: Mr. President, this act is one which comes under the emergency law, and which was passed two years ago by the unanimous request of the lobster fishermen of Hancock County. They find

that it has not worked to their advantage, as they expected it would, and they now wish to have attached to that the emergency clause, which requires a two-thirds vote of the Senate.

A vote being had 22 Senators voted in favor of the passage of the Act, and the same was passed to be enacted.

Resolve providing for the payment accounts claims. and demands against the State, accrued during the year 1908, on account of the deficiency in appropriation for the prevention and extinguishment of forest fires.

The PRESIDENT: This Resolve also has attached to it an emergency clause which requires an affirmative vote of the members elected to the Senate, in order that it may be passed.

A vote being taken, 22 Senators voted in favor of its passage and the resolve was finally passed.

I am sorry to say, sir, that in some cases their prayers have been answered; but I feel today that there is too much justice and too much business sense in this body of distinguished gentlemen to listen very long to such an appeal.
