1911

Ordered: That all bills, acts, resolves, orders and petitions which are to be introduced in the Senate shall be placed in the hands of the secretary of the Senate not later than 4 o'clock of the day preceding the introduction.

On motion by Mr. Boynton of Lincoln, the order relating to furnishing each member and officer of the Senate with newspapers, was taken from the table, and upon further motion by the same senator the order was given a passage.

(Recess.)

After recess, on motion by Mr. Boynton of Lincoln, it was

Ordered: That the secretary of State be directed to furnish each member and officer of the Senate with postage stamps to the amount of \$5.

On motion of Mr. Milliken of Aroostook, the Senate adjourned until Thursday, Jan. 12, 1911, at 10 o'clock in the forenoon.

Legal Affairs.

By Mr. Mitchell of Kittery: An Act to authorize the construction of a dam across the East Branch of Spruce Creek in the town of Kittery.

An Act to empower the county commissioners of York county to act under chapter 179 of the Laws of 1907 entitled "An Act to provide a way to free toll bridges."

Appropriations and Financial Affairs.

By Mr. Keilher of Portland: Resolve in favor of Maine Institution for the Blind.

By Mr. Goodwin of Biddeford: Resolve in aid of Trull Hospital Aid Association.

By Mr. Files of Gardiner: Resolve in favor of the Women's Christian Temperance Union Temporary Home for Children, with statement of facts.

By Mr. Stetson of Lewiston: Resolve in favor of the Central Maine General Hospital, Lewiston, Maine.

By Mr. Mitchell of Kittery: Resolution in favor of appropriating money to assist in freeing the Portsmouth Bridge.

Inland Fisheries and Game.

By Mr. Mitchell of Kittery: An Act to regulate fishing in York Pond so called situated in the town of Elliot, county of York.

An Act to regulate fishing in Polly Pond so called situated in the town of York, county of York.

An Act to regulate the fishing in Clarkson's Pond so called situated in the town of Kittery, county of York.

Counties.

By Mr. Harmon of Stonington: Petition of Davis T. Conly and 39 others for annexation of town of Isle au Haut to the county of Knox.

Federal Relations.

By Mr. Small of Machiasport: Resolve and memorial to the members of Congress to promote the efficiency of the life saving service.

From the last Legislature: Report of the special joint committee appointed by the Legislature of 1909 to inquire into the laws regulating juvenile courts which said committee was directed to report in writing to the Legislature of 1911, said report to be filed with the clerk of the House not later than December 1, 1910, with bill accompanying. (Tabled for printing pending reference to a committee on motion of Mr. Stetson of Lewiston.)

Orders.

On motion of Mr. Allen of Columbia Falls,

Ordered, That the clerk of the House procure 500 sheets of cards containing the order of procedure of the House for the use of members and officers of the House.

On motion of Mr. Otis of Rockland, Ordered, That the clerk of the House be authorized to procure all necessary supplies for the conduct of his office.

On motion of Mr. Williamson of Augusta,

Ordered, The Senate concurring, that the time for the reception of petitions and bills for private and special Legislation be limited to Wednesday, February 1, 1911, and that all such petitions and bills presented after that date be referred to the next Legislature, and that the clerk of the House cause copies of this order to be published in all daily papers of the State until January 28, 1911.

On motion of Mr. Strickland of Bangor,

Ordered, That the secretary of State

be directed to furnish each member and officer of the House with postage stamps to the amount of five dollars.

Orders of the Day.

Mr. Harmon of Stonington announced the attendance of Patrick Dunn, representative-elect from Brewer, and was charged with the duty of conducting him to the Governor and Council for the purpose of taking and subscribing the oaths necessary to qualify him to enter upon the discharge of his official duties.

On motion of Mr. Murphy of Portland,

Adjourned.
