Friday, March 17, 1911.

# Orders of the Day.

On motion of Mr. Allen of Jonesboro the rules were suspended and he introduced a Bill, An Act to amend Section 55 of Chapter 15 of the Revised Statutes relating to Free High schools; and on further motion by Mr. Allen the rules were suspended, the bill received its three readings and was passed to be engrossed.

Mr. ALLEN: Mr. Speaker, I move a suspension of the rules in order to introduce another measure, An Act to amend Section 31 of Chapter 17 of the Revised Statutes of 1903, relating to the registration of dentists. I will say that I introduced a bill some time ago relating to the registration of dentists and I understand from the secretary of the committee that it is to be reported favorably. Only yesterday my attention was called to another change that the friends of the bill desire in the law. and I would say that I haven't the slightest objection to this change; and I move that this bill be received at the present time and that it take its several readings without reference to a committee and be passed to be engrossed.

Mr. HERSEY: Mr. Speaker, I think that a measure so drastic in its nature as this, containing new legislation, coming at this late hour in the session, and which could not be considered by a committee with due notice, ought not to be put through under a suspension of the rules without advertising. I think it should be referred to the next Legislature.

Mr. ALLEN: Mr. Speaker, I move that the bill be tabled for printing pending its introduction into the Legislature.

The motion was agreed to.

٠

Mr. ALLEN: Mr. Speaker, I move a suspension of the rules to introduce another matter, which concerns the Methodist people and no one else. Some years ago, in 1887, there was a law passed authorizing certain men in the Methodist conference to hold in trust funds under the title of "Preachers' Aid Society," the interest of these funds to be used for the financial assistance of aged Methodist ministers. Now this fund has increased and the bill I have in my hand purposes simply to change the amount and authorizes this Preachers' Aid Society of the Methodist Episcopal church to hold a larger sum. It makes the change by striking out the word "fifty" and substituting the words "one hundred," so that this society can hold \$100,000 instead of \$50,000.

Mr. HRSEY: I would like to ask the gentleman whether he is acting for the Methodist Society of Maine?

Mr. ALLEN: Yes, sir.

Mr. HERSEY: And for that society you ask for the correction?

Mr. ALLEN: Yes, sir.

Mr. HERSEY: I have no objection.

The motion was agreed to and the bill was received by the House.

Mr. STRICKLAND: Mr. Speaker, I would suggest to the gentleman from Jonesboro that the matter might be referred to the committee on appropriations and financial affairs. They do not have to report on Monday.

Mr. ALLEN: Mr. Speaker, I have no objection. I move that the bill be reaferred to the committee on appropriations and financial affairs.

The motion was agreed to.

On motion of Mr. Bisbee of Rumford, the rules were suspended and he introduced a bill, An Act authorizing the Rumford Village Corporation to raise money for the purpose of cleaning its streets and removing garbage and other refuse and properly disposing of the same, and on further motion by Mr. Bisbee the rules were suspended, the bill received its three readings without reference to a committee and was passed to be engrossed.

Mr. HERSEY: Mr. Speaker, this is a public measure and affects every dentist in the State. There have been some meas-

ures of this kind before this Legislature. Now it is proposed to introduce a new measure at the closing hours of this session, too late to have a committee consider the matter by advertising and by the ordinary Lotice.

Mr. ALLEN: Mr. Speaker, I desire to ask a question of the gentleman. Will the gentleman suggest a committee to which this can be referred?

Mr. HERSEY: Mr. Speaker, I do not suggest a committee of this Legislature but of some other Legislature. I have heard no reason given by the gentleman why it should not have been introduced early enough to have a proper consideration. Now the proposition to run through this Legislature, under a suspension of the rules, a public measure is objectionable in regard to any public measure. If it was a private matter it might be all right; but the gentleman from Jonesborg does not represent this State or the public in this matter, and I claim that you might do a great injustice to the public by railroading a measure through this Legislature that concerns the great public. We ought not to establish such a precedent. You may send it to a committee, but I do not believe there is any committee that wants to act on a measure like that without notice. The committees are to report finally on the 20th. How can you do it by referring it to a committee? The gentleman asks me to suggest a committee to which it can be referred. It is not a matter of reference to a committee. It is a matter of receiving it at this time, and I believe we ought not to receive public measures at this time; and what I say now applies to every public measure coming in here.

Mr. SCATES of Westbrook: Mr. Speaker, for the benefit of the gentleman from Houlton and the gentleman from Jonesboro, I will say that there is a bill in relation to dentistry which was passed upon by the committee on legal affairs the other day. of us are liable to be in precisely the same position that the gentieman from Jonesboro finds himself in at the present time. Someone has sent him a measure and requests that he present it to the House. Could we do any less than to allow him to present it? That is the question which is pending here. There isn't anything else under consideration. We are not asked to railroad anything through, we are not asked to refer it to any committee. The gentleman from Jonesboro merely makes the request that this House receive at the present time a bill which somebody has sent him to present. What reason is there why we should not receive it? I know of none, Mr. Speaker.

Mr. Speaker, it strikes Mr. OTIS; me that this discussion is all out of order. A single objection stops it and that objection has been made.

It takes a two-The SPEAKER: thirds vote to set aside the rules and a two-thirds vote to allow this bill to be received at the present time.

ALLEN of Jonesboro: Mr. Mr. Speaker, the bill I introduced several days ago went before the committee on legal affairs. There were petitions I think from about every dentist in the State in favor of that bill. It was duly considered, and the secretary of the committee told me a few moments ago that they were to report unanimously that it ought to pass. Now when this matter came before the public it was found that there were some few features which should be corrected. T thought it was fair and I am willing that the change should be made. That is the only point of the bill. I have no desire to railroad anything through. I merely ask that the House consider this matter.

Mr. DAVIES: Mr. Speaker, I do not understand that the merits of this biil are under consideration at the present time in any way. The question pending. as I understand it, is merely this one: Shall the House receive the bill? After that the question of consideration comes, and that question is not before the House at the present time.

Mr. HERSEY: Mr. Speaker, I assume that whether this House receives a bill or not depends somewhat upon the nature of the matter. The House is entitled to some understanding of what it is going to receive. Mr. EMERY of Sanford: Mr. Speaker, I move a suspension of the rules in order to introduce An Act to divide the town of Sanford and incorporate the town of Springvale. By way of explanation I will say that the town of Sanford is the largest town in the State of Maine. It is made up of two villages, the northern district known as Springvale and the southern district known as Sanford. Springvale has a population of from 2000 to 3000. Sanford has somewhere between 6000 and 7000. Springvale has taxable property to the extent of one million dollars and Sanford perhaps four.

These two villages have been wrangling for a number of years as two villages will and they seem to get more heated as time goes on, and the Springvale section have appeared here today, or representatives of the Springvale district have appeared here today, and ask to have that bill presented.

Mr. TRIMBLE of Calais: Mr. Speaker, do I understand that this bill has to do with the division of a town in York county?

The SPEAKER pro tem: It apparently divides that town of Sanford and incorporates a new town by the name of Springvale.

Mr. TRIMBLE: Mr. Speaker, I dislike to appear unfriendly in this matter but those of us who were here two years ago remember how much of the time of this House was taken up over a discussion of a similar matter and how it continued for two years, and we also remember how much time has been taken up by this House over the discussion of similar matters in connection with other towns, and we know what the temper of this House is as to the division of towns, and it seems to me it is asking a good deal of us to introduce a bill at this time to open up a question that we practically have made up our minds against; and I for one strongly object to the House receiving this bill at this time. (Applause.)

Mr. EMERY of Sanford: Mr. Speaker, I recognize the fact that it is a late hour but this thing has been brewing for a long time and it seems that only yesterday they arrived at some definite conclusion as to just what action they would take—that is, in the northern district. I have heard nothing from the southern district.

Mr. ANDREWS of Norway: Mr. Speaker, I dislike to go against the gentleman from Sanford but it seems to me, as we have turned down two or three of that class of bills, I think it would be unwise to accept this bill at this time.

Mr. HERSEY: Mr. Speaker, the House this morning by its action indicated that such measures should not be received. We so treated the gentleman from Jonesport. I think everybody else should have the same treatment. I stand against putting in bills at this hour.

The question being on the motion to suspend the rules and receive the bill at the present time, a division was had and the motion was lost by a vote of 4 to 43.
