Mr. Goodwin of Biddeford moved a suspension of the rules to introduce a resolution:

Resolve, that in accordance with the great and general court which convened in this hall on the evening of March 28, the House presents the table No. 58, now used by the official stenographer of the House, to Representative Edward W. Murphy, in recognition of his zeal and persistency in laying matters on the table, and as a slight tribute of the esteem on the

part of the House to the gentleman from Portland who is hereby officially dubbed the watch dog of the treasury. (Applause.)

Mr. WILLIAMSON: Mr. Speaker, I object to that motion. If we were to give Mr. Murphy a table sufficient to hold all the matters he has tabled this session we would have to procure him an old-fashioned extension table. (Laughter.)

The question being the passage of the resolve, it was unanimously adopted by a rising vote.

An Act to amend Paragraph 1, Section 42 of Chapter 15 of the Revised Statutes, as amended, providing for payment from the State school fund for amounts paid on account of union superintendents.

An Act for the assessment of a State tax for the year 1911.

An Act to amend an Act for the equalization of school privileges.

An Act to repeal Chapter 142 of the Public Laws of 1905, relating to the support of alien paupers.

An Act relating to the salary of the judge of probate for Cumberland county.

An Act authorizing the State land agent to sell certain property of the State at Belgrade fish hatchery, in the county of Kennebec.

An Act relating to the assessment of county taxes in the several counties for the year 1911.

This bill contains the emergency clause and must receive 101 votes to entitle it to a passage.

A division being had, 105 voted in favor of its passage.

The bill was then passed to be enacted.

An Act defining the main trunk highway through the State.

An Act repealing Section 31 of Chapter 3 of the Revised Statutes, relating to certain amendments.

An Act for the encouragement of industrial education.

An Act to incorporate the Rumford and Mexico Water District.

An Act for the assessment of a State tax for the year 1912.

An Act additional to Chapter 17 of Revised Statutes, relating to autopsies. An Act in relation to the superior court of Cumberland county.

An Act granting H. L. Gooch the right to maintain a dam on the East Machias river.

An Act relating to the compensation of justices of the supreme judicial or superior courts.

Finally Passed.

Resolve in favor of Carl C. Jones, for services as clerk and stenographer to the committee on taxation.

Resolve in favor of J. M. Lane, for services as clerk and stenographer to the committee on telegraphs and telephones.

Resolve in favor of John Bradbury.

Resolve to amend Article 22 of the constitution, relating to cities of 40,000 inhabitants or more, to increase their municipal indebtedness to seven and one-half per centum.

The SPEAKER pro tem: This resolve will require a two-thirds vote of the members present and voting.

A division being had the resolve was finally passed by a unanimous vote.

Resolve authorizing the State land agent to convey Lot No. 9 in Castle Hill, Aroostook county, Maine, to Samuel Maynard of Castle Hill.

Resolve in favor of Cordelia Andrews of Oxford, widow of Freeman B. Andrews, soldier of the Civil War.

Resolve ratifying the proposed amendment to the constitution of the United States giving Congress the power to lay and collect taxes on incomes.

The SPEAKER protem: This resolve requires a vote of two-thirds of those present and voting in order to receive a passage.

A division was had and 101 voted in favor of its passage.
