HOUSE.

Wednesday, January 8, 1913.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Steele of Hallowell.

Journal of previous session read and approved.

Papers from the Senate disposed of in concurrence.

The following bills, petitions, etc. were presented and referred:

Judiciary.

By Mr. Boman of Vinalhaven: Resolve proposing an amendment to the constitution changing September election to November.

By Mr. Maybury of Saco: An Act to incorporate the Sweetser Orphan Asylum.

By Mr. Violette of Van Buren: An Act to authorize the Van Buren Water District to issue bonds.

By Mr. Sherman of Eden: An Act relating to the use of automobiles on the island of Mount Desert.

Railroads and Expresses.

By Mr. Mitchell of Kittery: An Act to repeal section two of chapter 13 of the Private and Special Laws of 1887, relating to the York Harbor and Beach Railroad.

By Mr. Haines of Fort Fairfield: Petition of Nicholas Fessenden and others of Fort Fairfield in aid of charter for railroad bridge between Van Buren, Maine, and St. Leonards, New Brunswick.

By Mr. Franck of St. Agatha: Petition of Hon. E. R. Michaud and others of Frenchville for same; also petition of Donat Franck and others of St. Agatha for same; also petition

of Remi A. Daigle and others of Madawaska for same; also petition of C. A. Gallupe and others of Frenchville for same.

By Mr. Violette of Van Buren: Petition of H. A. Gagnon and others for same; also petition of A. E. Hammond and others for same.

Ways and Bridges.

By Mr. Cyr of Fort Kent: Resolve in favor of highway bridge over the St. John river between Fort Kent and St. Francis, New Brunswick.

Orders.

On motion by Mr. Smith of Presque Isle it was

Ordered, the Senate concurring, that the committee on appropriations and financial affairs consider the matter of services rendered by the commission on enlargement of the State House and its clerk, and if in the judgment of the committee the commission and its clerk are equitably entitled to receive compensation for such services that the committee fix and recommend payment of such compensation as to it seems just and proper and report by resolve or otherwise.

The SPEAKER: The Chair wishes to call the attention of members of the House to the rule of the House in relation to depositing bills and petitions in the box in front of the Clerk's desk. It is important that the bills and petitions be deposited by or before five o'clock each day in order to have them considered and properly cared for as to details by the Clerk.
