#### HOUSE.

Tuesday, February 11, 1913.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Evans Gardiner.

Journal of previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Joint resolution in favor of the passage of the McLean Bill, U. S. Senate Document No. 6497, to afford federal protection to migratory game and insectivorous birds.

In the House this joint resolution was read and passed, and came from Senate amended bу Senate Amendment A.

The question being on the adoption of Senate Amendment A in concurrence.

The Amendment was adopted, and the joint resolution, as amended, then received a passage in concurrence.

Mr. AUSTIN of Phillips: Mr. Speak-An Act to extend the charter of the er, I would like to explain to the members of the House that this resolve becomes necessary owing to the fact that after the referendum became part of our organic law the monies for the support of the different departments of the State do not become available until the first day of July; that is, the monies appropriated by this Legislature will not become available for the different departments until July 1st. That leaves the fish and game department entirely without funds January 1st to July 1st. This resolve does not intend for the appropriation of \$25,000 in addition to any other appropriation; it simply intends to get the opportunity to use the \$25,000 as a general fish and game appropriation which this Legislature may hereafter pass. And as I say, it is simply a matter that has come up of late years since the passage of the referendum and is the usual procedure in the Leg-Islature in order to give this department the necessary funds to conduct its business in connection with the propogating and feeding stations and also to pay the salaries of their wardens up to July 1st. I hope with this explanation the members will see fit to give this resolve their unanimous support.

The SPEAKER: The question is on the final passage of this resolve. All those in favor of the passage of the resolve under the emergency clause will rise and stand in their places until counted.

Document House No. Order, the House concurring, that the committee on salaries and fees be directed to inquire into the expediency of appointing a special committee to sit during the recess and after adjournment of the present session; and to inquire into the amount of compensation received by all State and county officials whose salaries are determinable by the Legislature, and to report to the next Legislature such amounts as will make the salaries of said officials equitable throughout the State, was taken from the table, and on further motion by Mr. Austin, the order received a passage in concurrence.

On motion by Mr. Rolfe of Portland, House Document No. 143, bill, An Act relating to the board of overseers of the poor of Portland, was taken from the table, and on further motion by Mr. Rolfe the bill was referred to the Portland Delegation.

On motion by Mr. Peacock of Readfield, House Document No. 179, resolve to dedicate Crooked Island, so called, in Great Pond in the town of Rome, county of Kennebec, to the public use of the inhabitants of the State of Maine, was taken from the table, and on further motion by Mr. Peacock the resolve was referred to the committee on State lands and forest preservation.

On motion by Mr. Smith of Auburn, House Document No. 186, bill, An Act to encourage and promote the building and use of tuberculosis hospitals in cities and towns, was taken from the table, and on further motion by Mr. Smith the bill was referred to the committee on judiciary.

On motion by Mr. Washburn of Perry, House Document No. 155, bill, An Act to incorporate the Perry Telephone Company, was taken from the table, and on further motion by Mr. Washburn the bill was referred to the committee on telephones and telegraphs.

On motion by Mr. Washburn of Perry, House Document No. 161, bill, An Act to incorporate the Union Telephone Company, was taken from the table, and on further motion by Mr. Washburn the bill was referred to the committee on telephones and telegraphs.

On motion by Mr. Churchill of Madison, House Document No. 147, bill, An Act to amend an Act to incorporate the Madison Water Company, was taken from the table, and on further motion by Mr. Churchill, the bill was referred to the bill on judiciary.

On motion by Mr. Haskell of Portland, House Document No. 145, bill, An Act relating to the assistant assessors of the city of Portland, was taken from the table, and on further motion by Mr. Haskell the bill was referred to the committee on legal affairs.

On motion by Mr. Harriman of Cherryfield, Resolve in favor of a road in townships 9 and 10, in Hancock county, was taken from the table, and on further motion by Mr. Harriman, a statement of facts having been inserted, the resolve was referred to the committee on ways and bridges.

On motion by Mr. Mitchell of Kittery, Order in favor of the city of Saco, accompanied by statement of facts, was taken from the table.

In the House this order was referred to the committee on claims, and in the Senate the order was read and passed in non-concurrence.

On motion by Mr. Mitchell the House voted to recede and concur with the Senate in its passage of the order.

Ordered, That the use of the Hall of the House of Representatives be granted to the judiciary committee for hearing on the employers' liability act March 4th at two o'clock P. M.

On motion by Mr. Plummer of Lisbon, the vote was reconsidered whereby the House passed to be engrossed resolve for the further improvement of marketing the farm products and purchasing supplies for the farm, House Document No. 193, and on further motion by Mr. Plummer the resolve was tabled pending its passage to be engrossed.
