#### HOUSE.

Friday, February 14, 1913.

The House met according to adjournment and was called to order by the Speaker.

Prayer by Father LaRiviere of Augusta.

Journal of previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Joint resolution relating to measures in regard to legislation for regulation and control of public service corporations and inviting Hon. Robert LaFollette to address the members of the Legislature of Maine upon said subject, in the Hall of the House of Representatives on or about February 26, 1913.

The joint resolution received a passage in concurrence.

Ordered, the Senate: the From House concurring, that when the Senate and House adjourn it be to meet on Monday afternoon, February 17, at half past four o'clock.

Mr. PEACOCK of Readfield: Mr. Speaker, through an oversight yesterday, bill, An Act to repeal Chapter 340 of the Public Laws of 1907, relating to road in Readfield, was overlooked. This matter was tabled at my suggestion during my absence from the House. It was not tabled for the purpose of encumbering the docket of the House, but there is one other matter pending before this body which should be taken in connection with this particular matter. The other matter has not as yet been acted upon, and for that reason f move that this matter be laid upon the table, and I will take it up at the earliest possible mement.

Mr. AUSTIN of Phillips: Mr. Speaker, I would like to ask the gentleman from Readfield, Mr. Peacock, through the Chair, if it was not agreed that this matter should be assigned for next Tuesday, after the adjournment yesterday.

Mr. PEACOCK: Mr. Speaker and branches of this Legislature; and acted upon so that I would know

I did agree to have this matter considered last Tuesday, but it was before my consultation with the members of the other committee, from

whom I ascertained that no report would be made until later, i am perfectly willing to stand by iny agreement, and I only laid it upon the table without assigning a definite day for its consideration for the simple reason that I thought it would save a little time. If my brother insists, I am perfectly willing to assign it for next Tuesday.
