HOUSE.

Friday, February 28, 1913.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Boothby of Augusta.

Journal of previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Ordered, the House concurring, that when the Senate and House adjourn it be to meet on Monday afternoon, March 3d, at half past four o'clock.

In the Senate this order was read and passed and sent down for concurrence.

Mr. Quinn of Millinocket offered an amendment, to amend by substituting "that when the House adjourns they adjourn to meet on Tuesday, March 4th, at ten o'clock."

Mr. QUINN: Mr. Speaker, I will say that Monday is town meeting day in a great many towns in this State, and for that reason most of the members cannot get back here in time for the session on Monday, and for that reason I offer this amendment.

The SPEAKER: The Chair will state that it is necessary of course for the Senate to concur in the passage of any order. The Chair has been informed that the attitude of the Senate and of some of the members who have been consulted in the matter is that a session on Monday afternoon at four-thirty o'clock for the transaction of routine business only, would perhaps necessitate a very large attendance, it being understod that routine business only would be considered; in that way the business would be advanced one legislative day.

Mr. QUINN: Mr. Speaker, if there is nothing of very great importance to be considered I will withdraw my amendment.

The question being on the passage of the order in concurrence with the Senate,

The order received a passage in concurrence. From the Senate: Majority and minority reports of the committee on towns to which was referred bill, An Act to divide the town of Sanford and incorporate the town of Springvale.

In the House the minority report was substituted for the majority report, and came from the Senate the majority report being accepted in that branch in non-concurrence.

Mr. Folsom of Sanford moved that the House insist upon its action and ask for a committee of conference.

The motion was agreed to, and the speaker thereupon appointed as such committee of conference on the part of the House Messrs. Folsom, Peacock and Crowell.

From the Senate: Majority and minority reports of the committee on claims to which was referred resolve in favor of Michael Burns.

In the House the majority report of the committee was accepted, and the bill in new draft reported by the committee received its first reading; in the Senate the minority report was accepted in non-concurrence.

Mr. Quinn of Millinocket moved that the House insist upon its action whereby the majority report of the committee was accepted and ask for a committee of conference.

The motion was agreed to, and the Speaker thereupon appointed as such committee of conference on the part of the House Messrs, Quinn, Austin and Scates.

The following communication was received and placed on file on motion by Mr. Boman of Vinalhaven:

"To the Honorable Senate and House

of Representatives.

In compliance with your order of February 25, 1913, relating to the payment of wages weekly by 'the its officers, boards and commissions to every mechanic, workman and laborer who is employed by it or them' as provided by Chapter 39 of the Public Laws of 1911, have to inform you that Section five of Article five of the Constitution of Maine provides that 'no money shall be drawn from the treasury, but by warrant from the Governor and Council. And I beg leave to report that such warrants for wages have been received by this department once every month and payment has been made promptly on same. But I have been informed on line of economy that one of the institutions has made an agreement satisfactory to their employes whereby their treasurer will pay monthly. Assuming that this may have been followed out in other departments, I remain,

Mr. Sanborn from the committee on judiciary, reported "ought to pass" on bill, An Act to confer equity jurisdiction upon the supreme judicial court to hear and determine property matters between wife and husband or husband and wife.

The report was accepted, and this bill having been printed received its first and second reading and was assigned for next Monday afternoon at 4.30 o'clock for its third reading.

Mr. Peaks from the committee on legal affairs, reported "ought to pass" on bill, An Act to amend Section 50 of Chapter 93 of the Revised Statutes of Maine, as amended by Chapter 21 of the Public Laws of 1907, relating to liens on pulp wood.

The report was accepted, and this bill having been printed received its first and second reading and was assigned for next Monday afternoon at 4.30 o'clock for its third reading.

Mr. Peacock from the committee on legal affairs, reported "ought to pass" on bill, An Act to amend Section 28 of Chapter 65 of the Revised Statutes, relating to appeals from orders, sentences, decrees or denials of judges of probate.

The report was accepted, and this bill having been printed received its first and second reading and was assigned for next Monday afternoon at 4.30 o'clock for its third reading.
