HOUSE.

Monday, March 3, 1913. The House met according to adjourn-

ment and was called to order by the Speaker.

Prayer by the Rev. Mr. Stanley of Hallowell.

Journal of previous session read and approved.

Papers from the Senate disposed of in concurrence.

(Mr. Austin of Phillips at this point assumed the Chair.)

From the Senate: A communication was received from the Senate stating that in that branch Messrs. Smith, Wing and Maxwell had been joined on the committee of conference on the disagreeing action of the two branches on bill, An Act to amend Chapter 40 of the Revised Statutes, as amended by Chapter 46 of the public Laws of 1907 and Chapters 70 and 257 of the Public Laws of 1909, relative to the employment of women and children.

Senate Bills on First Reading.

An Act for the better regulation of the practice of dentistry and the reorganization of the Board of Dental Examiners.

An Act to extend the charter of the World's Standard Insurance Company.

An Act to amend section 116 of Chapter 15 of the Revised Statutes, relating to instruction for the blind.

A. Judkins and 66 others asking for the repeal of the 30-day limit on shipments of 10 pounds of fish under tag.
