#### HOUSE.

#### Monday, March 10, 1913.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Phelan of Augusta.

Mr. SMITH of Patten: Mr. Speaker, I desire to make a statement for the purpose of correcting in a slight degree the Legislative Record of March 7th. In the course of the debate in regard to the emergency clause for the Bar Harbor automobile bill, found on Page 714, my remark in reply to the gentleman from Phillips, Mr. Austin, is made to read as follows: "I cannot let the statement of the gentleman from Phillips go unchallenged. Any lawyer will know that we have the right to read any language into the Constitution of this State." It should read: "Any lawyer will know that we have no right to read any language into the Constitution of this State." a typographical error using the word "the" instead of "no"; and I ask to have this correction made.

There being no objection, the correction was ordered to be made accordingly.

Journal of previous session read and approved as amended.

On motion by Mr. Plummer of Lisbon, Senate Document No. 395, bill, An Act to punish the making or use of false statements to obtain property or credit, was taken from the table, and on further motion by Mr. Plummer the bill received its third reading and was passed to be engrossed.

On motion by Mr. Plummer of Lisbon, the report of the committee on judiciary, reporting "ought not to pass" on bill, An Act to permit the election of town officers by secret ballot, was taken from the table, and on further motion by Mr. Plummer the report of the committee was accepted.

The SPEAKER: The Chair will lay before the House under unfinished business, the motion of the gentleman from Lisbon, Mr. Plummer, to reconsider the vote whereby the bill, An Act for the better regulation of the practise of dentistry and to re-organize the Board of Dental Examiners was passed to be engrossed.

Mr. PLUMMER: Mr. Speaker, I understand there are several of the members who are not present at this time and who are interested in this matter, and if the House is willing I should be glad to have the matter again laid upon the table and assigned for tomorrow.

Mr. Pendleton of Searsport moved that the matter be laid upon the table and specially assigned for consideration, Wednesday, of this week.

The motion was agreed to.
