Monday, March 24, 1913.

The House met according to adjournment and was called to order by the Speaker.

Prayer by Rev. Mr. Stanley of Hallowell.

Journal of previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Remonstrance of Charles J. Rush and 100 others of Millinocket against passage of Senate bill, No. 318, being An Act to provide a license for residents to hunt wild birds and animals.

In the House this remonstrance was referred to the committee on inland fisheries and game, and came from the Senate in that branch placed on file in non-concurrence.

On motion by Mr. Austin of Phillips, the House voted to recede and concur with the Senate in ordering this remonstrance placed on file.

From the Senate: An Act for the better protection of the needy and deserving.

In the House this bill was referred to the committee on public health, and came from the Scnate in that branch indefinitely postponed.

On motion by Mr. Austin of Phillips, the House voted to recede and concur with the Senate in the indefinite postponement of this bill.

> Mr. SARGENT of Portland: An income tax is the most just tax in the world, and it is no burden on anybody. Nobody will go hungry, cold or naked on its account.

> The bill provides for a tax on one per cent. on an income over and above \$2500 to \$5000, which will be a tax of \$25 to \$50! from \$5000 to \$7500, 1 1-2 per cent., which would be a tax of \$75 to \$112; from \$7500 to \$10,000, two per cent., which would be a tax of \$150 to \$200; from \$10,000 up to \$15,000, 2 1-2 per cent. which would be a tax of \$250 to \$375, and \$15,000, three per cent. would be \$450; all over \$15,000 will be three per cent. a year.

or any of those millionaires, and it is that the federal government has passnot right. They have got millions upon millions to be protected by this government, and it is no more than right that they should pay something towards it. If we have a war it is the common man that goes to war-that has to go in and fight the battles and preserve the country. The rich man can take his money and buy a substitute.

Some say it is double taxation. Well. how big is this double tax? Why, if you put it on incomes it is just about one-twentieth what we have to pay on property. Take, for illustration, an income of \$5000. A man has got \$100,000, at 5 per cent, the income would be \$5000, and he would have to pay \$25 tax on it. It is an awful burden on him isn't it? A man that has \$100,000 worth of real estate has to pay over \$2000 tax; so if we have a government tax and a State tax the rich man is only paying just about one-tenth of what we pay on real estate and other property. That is all I have to say just now.

Mr. IRVING of Caribou: Mr. Speaker, just a word regarding the report of the committee. This bill came to your committee about 10 days ago, and was considered by them. They regard it as a matter of too great importance to pass hastily upon, in face of the fact ed an income tax law which has only only recently been ratified and accepted by a sufficient number of the states to make it operative.
