HOUSE.

Monday, March 31, 1913.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Clark of Gardiner.

Journals of Friday, March 28, 1913, and of Saturday, March 29, 1913, read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: An Act authorizing the secretary of State to prepare and publish the corporations delinquent in payment of their franchise taxes and providing for the expenses of such publication.

In the Senate this bill was received under a suspension of the rules and was passed to be engrossed without reference to any committee.

On motion the rules were suspended and the bill received its first and second readings without reference to a committee and was assigned for tomorrow morning for its third reading.

From the Senate: An Act to legalize the doings of the stockholders of the Aberthaw Construction Company.

In the House this bill was passed to be engrossed, and came from the Senate in that branch indefinitely postponed in non-concurrence.

On motion by Mr. Smith of Auburn the bill was tabled pending concurrent action with the Senate.

From the Senate: An Act granting to the Knox County Power Company the right to generate and sell electricity in the municipalities of Thomaston and Rockland, together with pole rights therein.

In the House the bill was substituted for the report of the committee, reporting "ought not to pass," and the bill was passed to be engrossed; in the Senate the report of the committee, reporting "ought not to pass" was accepted in non-concurrence with the House.

On motion by Mr. Doherty of Rockland the bill was tabled pending concurrent action with the Senate. From the Senate: An Act to establish a reformatory for women.

In the Senate the report of the committee reporting "ought to pass" was accepted and the bill was referred to a special joint committee appointed to investigate proposals relating to extension of the scope of work and equipment of the State School for Boys at South Portland and the Industrial School for Girls at Hallowell and the establishing of a reformatory for women.

On motion by Mr. Perry of Washburn the report was accepted and the bill was referred to the above committee in concurrence with the Senate.

From the Senate: An Act to amend Section 54 of Chapter 8 of the Revised Statutes, relating to the taxation of savings banks.

In the House this bill was passed to be engrossed, and came from the Senate in that branch indefinitely postponed in non-concurrence with the House.

On motion by Mr. Newbert of Augusta the House voted to adhere to its former action in passing the bill to be engrossed.

From the Senate: An Act prohibiting marriages in certain cases.

In the Senate the majority report of the committee reporting "ought to pass" was accepted; subsequently in that branch the bill was indefinitely postponed.

On motion by Mr. Boman of Vinalhaven the House voted to concur with the Senate in the indefinite postponement of the bill.

From the Senate: An Act for the better protection of automobile garage keepers and owners.

In the Senate this bill was passed to be engrossed; in the House the bill was indefinitely postponed in non-concurrence. The bill then went to the Senate, that branch voting to insist on its former action and asking for a committee of conference, the President of the Senate having appointed as such committee of conference Sanators. Bailey, Patten and Allen.

On motion by Mr. Thombs of Lincoln the bill was laid upon the table pending concurrent action with the Senate.

From the Senate: An Act to abolish the Belfast municipal court and to establish a police court for the city of Belfast.

In the Senate this bill was passed to be engrossed, and in the House the bill was indefinitely postponed.

In the Senate on March 28th, that branch voted to insist and ask for a committee of conference, appointing as members of such committee Senators Conant, Smith and Wing.

On motion by Mr. Thombs of Lincoln the House voted to adhere to its former action in the indefinite postponement of the bill.

From the Senate: An Act to amend Section 1 of Chapter 7 of the Revised Statutes, relating to the appointment of land agent.

In the Senate this bill was passed to be engrossed, and in the House the bill was indefinitely postponed.

In the Senate that branch voted to insist upon its action and asked for a committee of conference, appointing as members of such committee Senators Colby, Chase and Reynolds.

Mr. Dunbar of Jonesport moved that the House adhere to its former action in the indefinite postponement of the bill.

Mr. MARSTON of Skowhegan: Mr. Speaker, I hope the motion of the gentleman from Jonesport (Mr. Dunbar) will not prevail. I understand there is a possibility that this bill may be so changed and amended that it will be agreeable to the House. I feel that if we could, we should appoint a committee representing the opponents of the bill, in the hope that they may agree upon a new draft which would be acceptable; consequently I hope the motion will not prevail.

Mr. NEWBERT of Augusta: Mr. Speaker, I do not believe the State of Maine is suffering for any new legislation along this line. I think this this House is perfectly satisfied with the condition as it is, and I second the motion of the gentleman from Jonesport (Mr. Dunbar) that the House adhere. Mr. AUSTIN of Phillips: Mr. Speaker, 1 would move, if it be in order, that the House grant the request of the Senate for a committee of conference.

The SPEAKER: This motion takes precedence of the motion to adhere, which is the last in the list of concurrent motions.

Mr. Dunbar of Jonesport moved that the matter be laid upon the table and specially assigned for consideration, on Wednesday of this week, pending concurrent action with the Senate.

The motion was agreed to.

From the Senate: An Act to amend Chapter 256 of the Private and Special Laws of 1907, relating to the Cumberland County Power and Light Company.

In the House this bill was referred to the committee on judiciary, and came from the Senate in that branch passed to be engrossed as amended by Senate Amendment A, without reference to any committee.

On motion by Mr. Kelleher of Portland, Senate Amendment A was adopted in concurrence, and on further motion by Mr. Kelleher the rules were suspended, the bill received its first and second readings without reference to a committee and was assigned for tomorrow merning for its third reading.

From the Senate: Ordered, the House concurring, that the joint standing committee on appropriations and financial affairs be directed to make up the pay-roll for the members of the House and Senate and for the House and Senate officers for the year 1913.

The order received a passage in concurrence.

An Act relating to the jurisdiction of the superior court in the county of Kennebec. (Tabled pending its passage to be enacted on motion by Mr. Swift of Augusta.)

An Act relating to the construction of sidewalks in the town of Sanford. An Act to amend Section 97 of Chapter 15 of the Revised Statutes, as amended, relating to appropriation for schooling children in unorganized townships.

On motion by Mr. Jones of China, resolve in favor of commission on enlargement of the State House was taken from the table, and on further motion by Mr. Jones the resolve received its second reading and was passed to be engrossed.

On motion by Mr. Chick of Monmouth the vote was reconsidered whereby the House concurred with the Senate in referring to the next Legislature bill, An Act to legalize and confirm the action of the Litchfield Plains Cemetery Associtation at its annual meeting on the seventh day of December, 1912.

In the House this bill was referred to the committee on legal affairs, and came from the Senate in that branch referred to the next Legislature in non-concurrence.

Later in the House that body reconsidered its former vote and concurred with the Senate in its reference of the bill to the next Legislature, on March 26th.

On motion by Mr. Chick, under a suspension of the rules, the House reconsidered the vote whereby it voted to concur with the Senate in its reference of the bill to the next Legislature, and on further motion by Mr. Chick the bill was laid on the table pending concurrent action with the Senate.

On motion by Mr. Pendleton of Searsport.
