Wednesday, Jan. 6, 1915.

In convention of members-elect of the House of Representatives of the 77th Legislature.

This being the day designated by the Constitution of the State for the meeting of the 77th Legislature, the members-elect of the House of Representatives assembled in the hall of the House of Representatives at 10 o'clock A. M., and were called to order by William R. Roix, the clerk of the last House.

Prayer was offered by Rev. Mr. Boothby of Augusta.

A communication was received from the secretary of State transmitting a certified roll of the representativeselect of the 77th Legislature.

A call of the roli by the clerk revealed the presence of a quorum, 145 members-elect answering to their names.

On motion by Mr. Connors, Messrs. Connor of Bangor, Sanborn of South Portland, Pierce of Houlton, Ricker of Castine, McCarty of Lewiston, Morse of Rumford and Perkins of Augusta, were appointed a committee to wait upon the Governor and inform him of the presence of a quorum of the members-elect of the House of Representatives in the hall of the House of Representatives, and request his attendance to administer the oath required by the Constitution to enable them to enter upon the discharge of their official duties.

Subsequently Mr. Connors reported that the committee had discharged the duty assigned it, and that His Excellency, the Governor, was pleased to say that with his Council he would forthwith attend upon the convention for the purpose indicated in the message.

The report of the committee was accepted.

Thereupon the Governor, accompanied by his Council, came in and administered and the members-elect subscribed the oaths necessary to qualify them to enter upon the discharge of their official duties.

The Governor and Council then withdrew.

In House of Representatives
On motion by Mr. Connellan, Messrs.

Connellan of Portland, Robinson of Bangor, Maxwell of Boothbay Harbor, Currier of Camden, Waterhouse of Kennebunk, Thombs of Lincoln and Washburn of Perry were appointed a committee to receive, sort and count votes for Speaker.

Having attended to the duties assigned it, Mr. Connellan from the committee reported 149 votes cast; that B. H. Lawrence had five votes; that Leon F. Higgins had 68 votes, and that Herbert W. Trafton had 76 votes.

The report was accepted.

Herbert W. Trafton was thereupon declared elected Speaker of the House for the present session, and was conducted to the chair by Mr. Higgins.

Mr. HIGGINS: Gentlemen of the House, it gives me great pleasure to present to you the honored member of this House from Fort Fairfield whom we have just elected as our Speaker for the present session. (Applause)

The SPEAKER: Gentlemen of the House of Representatives, I thank you most sincerely for the distinguished honor you have just conferred upon me in choosing me to be the presiding officer of this body. I recognize the fact that this is one of the honors which this House can confer upon any man; I recognize also the fact that this position carries with it grave responsibilities and arduous duties. I shall ask you, gentlemen, to assist me in the performance of those duties. I shall be obliged to ask for your indulgence many times during our session here this winter. I have no doubt but I will make many mistakes, but I can only say that it will be my endeavor in presiding over the deliberations of this body to act fairly and to recognize the rights of every man here. We are come together, gentlemen, as representatives of the good old State of Maine, and while party organization is necessary in conducting the affairs of this State, and while we were elected here to this body perhaps as Democrats or as Republicans or as Progressives, now, gentlemen, having taken the solemn oath of office which we have just taken this morning, we are not Democrats, we are not Republicans, we are not Progressives, we are representatives of

the good old State of Maine, and it is our duty to act and to do such things as shall most redound to the honor and glory of our State.

Gentlemen, again I thank you and again I ask your indulgence in conducting the affairs of this office; the Chair now awaits your pleasure. (Applause)

A message was received from the Senate through Mr Durgin of Piscataquis, informing the House that the Senate had been duly organized by the choice of Hon. Ira G. Hersey of Aroostook, as President, William E. Lawry of Augusta as secretary and L. Ernest Thornton of Houlton as assistant sec-

On motion by Mr. Clifford, Messrs. Clifford of Lewiston, Drapeau Brunswick, Wilkins of Jay, Hill of Corinth, Greenlaw of Presque Isle, Besse of Clinton and Wise of Guilford were appointed a committee to receive, sort and count votes for Clerk of the House for the present session.

Having attended to the duty assigned it, Mr. Clifford from the committee reported 151 votes cast; necessary for a choice 76; N. P. Gould had five votes; William R. Roix had 69 votes Chandler C. Harvey had 77 votes.

The report was accepted, and Chandler C. Harvey was declared duly elected Clerk of the House for the present session.

On motion by Mr. Goodwin, Messrs. Goodwin of Mexico, Gerrish of Greenville, Tate of Topsham, Libby of Merrill, Fay of Dexter, Beal of Cornville and Ames of Stockton Springs were appointed a committee to receive, sort and count votes for assistant clerk.

Mr. Higgins of Brewer: Mr. Speaker, the hour is getting late and I am going to make a suggestion to the effect that we will withdraw our candidate for the position of assistant clerk of this House, and if it is agreeable to the House, I would suggest that one vote by cast by the chairman of the committee gentleman for the representing the dominant provided our friends, the Progressives, resolution for a joint convention.

The motion was agreed to.

Mr. Goodwin of Mexico thereupon cast a vote in favor of Fortunat Belleau who was declared elected assistant clerk for the present session.

On motion by Mr. Greenleaf of Portland, their gentleman was charged with a message to the Governor notifying him of the organization of the House by the election of a speaker, clerk and assistant clerk.

Mr. Greenleaf subsequently reported that he had discharged the duty assigned him.

The report was accepted.

On motion by Mr. Gallagher of Bangor, that gentleman was charged with a message to the Senate informing that body of the organization of the House by the election of a speaker, clerk and assistant clerk.

Mr. Gallagher subsequently reported that he had discharged the duty assigned him.

The report was accepted.

On motion by Mr. Plummer of Lisbon, that gentleman was charged with the duty of conducting the clerk and assistant clerk to the Governor to receive and subscribe the oaths necessary to qualify them to enter upon the discharge of their official duties.

Mr. Plummer subsequently reported that he had performed the duty assigned him.

The report was accepted.

The clerk and assistant clerk then assumed charge of their respective positions.

A communication was received from the Senate through its secretary proposing a joint convention of the two branches of the Legislature at two o'clock P. M. in the hall of the House of Representatives for the purpose of electing a Secretary of State, State Treasurer, Attorney General, Commissioner of Agriculture and seven Executive Councillors.

On motion by Mr. Thombs of Linparty, coln, the House voted to concur in the the Clerk of the House was charged with a message to the Senate signifying the concurrence of the House in the proposition for a joint convention.

The Clerk of the House subsequently reported that he had charged the duty assigned him.

From the Senate: Ordered. the House concurring, that the return of votes for Governor given to the several cities, towns and plantations of the State for the political years 1915 and 1916 be referred to a joint select committee of seven on the part of the Senate with such as the House may join.

The order received a passage in concurrence.

From the Senate: Ordered. House concurring, that the joint rules and orders of the years 1913 and 1914 be the joint rules and orders of the Legislature.

The order received a passage in concurrence.

the Senate: Ordered, the House concurring, that a joint committee on reference of bills, resolves, orders and petitions be appointed consisting of one on the part of the Senate and two in the part of the House, with the President of the Senate and the speaker of the House members ex-officio, whose duty it shall be to refer to the proper committees all bills, resolves, orders and petitions offered in either House.

On motion by Mr. Perkins of Augusta, Ordered, That the secretary of State be directed to deliver to the clerk of the House one copy of the Holy Bible, one copy of Webster's Unabridged Dictionary, one copy of the Standard Dictionary, one copy of Lippincott's Pronouncing Gazeteer and one copy of Cushing's man-1121.

On motion by Mr. Higgins of Brewer, Ordered, That the clerk of the House be authorized to procure a typewriter and procure the services of a stenographer during the present session of the Legislature.
