The following bills, petitions, etc., were presented and, on recommendation of the committee on reference of bills, were referred to the following committees:

Appropriations and Financial Affairs.

By Mr. Clifford of Lewiston: Resolve in favor of the Girls' Orphanage of Lewiston, with statement of facts.

By Mr. Haraden of Bath: Resolve in favor of the People's Ferry Company for maintenance.

Inland Fisheries and Game.

By Mr. Chadbourne of Baldwin: Petilion of Philip F. Decormier and 34 others from the town of Standish relating to the taking of black bass in Sebago Lake.

By Mr. Snow of Mars Hill: An Act to amend Section two of Chapter 32 of the Revised Statutes, as amended by Chapter 206 of the Public Laws of 1913, relating to fishing in a portion of Presque Isle Stream and certain tributaries to said stream in the county of Aroostook.

By the same gentleman: Petitions of R. T. Snow, W. C. McLeod, E. M. Fulton, Linwood L. Taylor, J. H. Farley and A. O. Nutter and 206 others, residents of Aroostook county, asking that Presque Isle Stream and its tributaries, in Aroostook county, be opened to fishing under the general law.
