From the Senate: The order relative to the time limit for the reception of private bills and petitions, passed in the House January 19th, 1915, came from the Senate amended by Senate Amendment A.

Mr. GREENLEAF of Portland: Mr. Speaker, as I understand it, by the terms of Senate Amendment A, this is a compromise date between the date fixed by the original House order and a later date which had been settled upon. It was not the intention of the order to fix any particular date arbitrarily for the purpose of shutting off any legislation, but it was thought that perhaps that was as convenient a date as could be arrived at under all the circumstances, and in view of that I now move that the House concur in the adoption of Senate Amendment A which makes the date one week later for the reception of petitions and bills for private and special legislation.

I will say also, if I may be allowed one further word in explanation, in regard to the latter part of the order, stating that all bills received after that time should be referred to the next Legislature, I think that is a matter of little consequence whether they be referred to the next Legislature or indefinitely postponed. It might at first blush be thought that referring these matters to the next Legislature would be a method of letting these petitioners down easy, but in- favor of the Maine State Sanatorium As-
