On motion of Mr. Plummer of Lisbon, House Doc. No. 54, An Act to extend the charter of the Monson Water Company, was taken from the table, and on further motion by Mr. Plummer the bill received its third reading and was passed to be engrossed.

Mr. PLUMMER of Lisbon: Mr. Speaker, I have here a petition in favor of the constitutional amendment giving the right of suffrage to women, and inasmuch as the hearing is to be held tomorrow, I move that the petition be received under a suspension of the rules in order that it may go to the Senate in time for the hearing tomorrow.

The rules were suspended and Mr. Plummer introduced out of order the petition of Elizabeth Snow and 32 others of Lisbon and vicinity in favor of the constitutional amendment giving the right of suffrage to women, and on further motion by Mr. Plummer the petition was referred to committee on judiciary.

Mr. SNOW of Mars Hill: Mr. Speaker, I also have a petition to the same effect and I would move that the petition be received under a suspension of the rules.
