HOUSE.

Friday, February 12, 1915.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Brokenshire of Hallowell.

Journal of previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Ordered, the House concurring, that when the Senata and House adjourn it be to meet on Tuesday forenoon, February 16, at 10 o'clock.

The order received a passage in concurrence.

From the Senate: Petition of H. G. Emery and 36 others in favor of investigations of institutions by county commissioners or grand jurors.

In the House this petition was referred to the committee on legal affairs, and comes from the Senate referred in that branch to the committee on judiciary in non-concurrence.

The House voted to recede and concur with the Senate in the reference of the petition to the committee on judiciary.

From the Senate: An Act amendatory of Sections 27 and 28 of Chapter 129 of the Public Laws of 1913, relating to corporations for the operation of telegraphs or telephones and other public utilities.

In the House this bill was referred to the committee on telegraphs and telephones, and comes from the Senate recomitted in that branch to the committee on reference of bills, in nonconcurrence.

The House voted to recede and concur with the Senate in recomitting the bill to the committee on reference of bills.

From the Senate: Resolve in favor of the repair of highway in Caratunk Plantation, House Doc. No. 55.
