HOUSE.

Saturday. March 6, 1915.
The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Hope of Augusta.

Journal of previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Resolve in favor of the Eastern Maine Orphans' Home for Maintenance.

This resolve was introduced in the Senate under a suspension of the rules and referred to the committee on appropriations and financial affairs. (Tabled pending concurrent action on motion by Mr. Welch of Machiasport.)

From the Senate: Ordered, The House concurring, that when the Senate and House adjourned it be to meet at 9 o'clock in the forenoon Tuesday, March 9, 1915.

The SPEAKER: I would suggest that it would be well before presenting this order to make the hour at 10 o'clock, as some of the members that went home did so with that understanding; but the Chair does not wish to dictate.

Mr. ST. CLAIR of Calais: Mr. Speaker, I think most of the members who have gone home intend to be here Monday night, so as to be here in time to attend the opening of the session at 9 o'clock Tuesday morning.

Mr. SMITH of Hampden: Mr. Speaker, I think the delegation from Baugor will not get here until 9.39 in the morning.

Mr. ST. CLAIR: Mr. Speaker, the feeling that I have in this matter is that we have already been here over two months, and we ought to finish up this legislative session this month, and it seems to me that the legislators should be here to do their work and that we should do as much work as possible at each session. If members choose to go home, it does not seem

to me that the legislative business of the State of Maine should be held up because a few of them would not be back here Monday night.

Mr. SMITH: Mr. Speaker, if it becomes imperative, we might stay an hour later in the afternoon and have an afternoon session, and so far as the train service is concerned the delegations from the eastern part of the State will not arrive here until within half an hour after the time of opening if we concur with the Senate; and I move that when we adjourn it be to 10 o'clock Tuesday morning.

The motion was seconded.

The question being on the motion to amend the Senate Order by substituting the word "ten" for the word "nine",

Mr. Benn of Hodgdon called for a division.

The SPEAKER: The Chair will suggest that a division would not be very desirable at this time.

Mr. ST. CLAIR: Mr. Speaker, there ought to be some way of ascertaining whether the majority of the members present desire to adjourn this House until 9 o'clock Tuesday morning or not. If the gentlemen on the other side wish to raise the point that there are not enough of us here to do business, that is another matter. We have here a respectable number of members of the House, and undoubtedly some of them are anxious to do the business of the House, and there ought to be some way of finding out whether it is the sense of these members to adjourn to 9 o'clock or until 10 o'clock. Personally, I think we ought to be here at 9 o'clock on Tuesday morning ready to do the business of the House.

The SPEAKER: The Chair will put the question to a viva voce vote, and if that does not ascertain the desire of the members we will ascertain in some other method.
