Saturday, March 13, 1915.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Burgess of Augusta.

Journal of previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Ordered, The House concurring, that when the Senate and House adjourn it be to meet at ten o'clock in the forenoon, March 16th, 1915.

The order received an passage in concurrence.

Senate Bills on First Reading.

Senate 293: Resolve in favor of the Treasurer of State to enable him to properly balance and settle the accounts with the various cities, towns, and Plantations for the State for the year 1914.
