Saturday, March 20, 1915.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Dow of Gardiner.

Journal of previous session read and approved.

Papers from the Senate disposed of in concurrence.

Mr. PIERCE of Houlton: Mr. Speaker, I wish to state to the House that the matter in connection with the women's reformatory having been arranged satisfactorily to the committee, to the Senate and the Governor, I would request unanimous consent that the resolve establishing the same be returned to the Governor. That seems to be satisfactory to all concerned, and I therefore move that the messenger of the House be requested to return the same to the Governor.

The motion was agreed to, and the messenger was charged with the duty of returning the document to the Governor.

From the Senate: Ordered, the House concurring, that when the Senate and House adjourn, it be to meet Tuesday, March 23rd, at 10 o'clock in the forenoon.

The order received a passage in concurrence.

From the Senate: Resolve in favor of the physician at the Maine State prison.

Orders of the Day

Mr. Morse of Rumford presented the following order:

Ordered, That the use of the House of Representatives be granted to the committe on railroads and expresses Thursday afternoon, March 25th, for a hearing upon the re-organization of the Boston & Maine Railroad.

The order received a passage.

Mr. PIERCE of Houlton: Mr. Speaker, a matter has been considered at the session this morning relating to the distribution of the State bond issue for highways among the different counties. It was introduced yesterday in the House under a suspension of the rules by the gentleman from Woodstock, Mr. Perham, and referred to the committee on ways and bridges. The matter was sent to the Senate, and, as I understand it, either by an accident or by an oversight, the Senate voted to non-concur and indefinitely postpone the measure. In the House this morning this matter was tabled and specially assigned for consideration on Tuesday of next week. By request of the Senator from Somerset, Senator Colby, I would ask that the House reconsider its vote whereby this matter was tabled and specially assigned for next Tuesday.

The motion was agreed to, and the vote was reconsidered.

On further motion by Mr. Pierce, the House voted to insist upon its action in the reference of the bill to the committe on ways and bridges, and ask for a committee of conference.

The Speaker thereupon appointed as

such committee on the part of the House kind upon a matter which has been of Houlton and Wescott of Bluehill.

Augusta: Mr. Mr. PERKINS of Speaker, I move that that bill, An Act to provide for semi-monthly payments on account of State contracts, be taken from the table. I will say that this matter was tabled yesterday by the gentleman from Brewer, Mr. Higgins, and I would like to have it taken from the table and referred to the committee on legal affairs.

The SPEAKER: The Chair will state to the gentleman from Augusta, Mr. Perkins, that it would be rather an unusual proceeding to take action of that March 23d, at ten o'clock.

Messrs Perham of Woodstock, Pierce tabled by a gentleman who is absent, unless the same is done by arrangement with the gentleman who tabled it.

> Mr. PERKINS: Mr. Speaker, I have not made any such arrangement with the gentleman from Brewer, Mr. Higgins, and I thought the gentleman would be present today. The only reason for my making this motion is that there will be a report filed on Tuesday of next week in all probability, and at that time the matter may be taken up for consideration. I will withdraw my motion.
