Tuesday, January 21, 1919.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Boothby of Augusta.

Journal of previous session read and approved.

Papers from the Senate disposed of in concurrence.

The following bills, resolves and petitions were presented and, upon recommendation of the committee on reference of bills, were referred to the following committees:

Agriculture

By Mr. Storm of New Sweden: An Act to amend Section 3 of Chapter 130 of the Revised Statutes relating to sale of milk.

By Mr. Wilson of Presque Isle: An Act to provide for conducting scientific investigation bearing upon the agriculture of Aroostook county.

Education

By Mr. Storm of New Sweden: Resolve in favor of Westmanland plantation for the payment of school funds forfeited by failure to file returns.

By the same gentleman: Petition of Anton Storm and eight others of Westmanland plantation, requesting the favor of 6 per cent. interest on the wild lands school fund.

Legal Affairs

By Mr. Garcelon of Auburn: An Act to repeal Chapter 288 of the Public Laws of 1917, relating to the keeping and sale of dynamite, powder and other explosives. (500 copies ordered printed).

By the same gentleman: Resolve proposing an amendment to Section 5, Article 4, part first, of the Constitution, as amended by the 23rd Amendment, relative to absent voting. (500 copies ordered printed).

Library

By Mr. Forbes of Paris: Resolve authorizing the purchase by the State of 100 copies of a History of Norway.

Pensions

By Mr. Swift of Greenwood: Resolve in favor of Joann P. Libby of Lockes Mills, town of Greenwood.

Taxation

By Mr. Allan of Portland: Bill, An Act to amend Section 28, Chapter 10 of the Revised Statutes of Maine, relative to the rate of taxation of sailing vessels and barges.

Ways and Bridges

By Mr. Foss of Hancock: Resolve in favor of repairing a highway in the town of Hancock.
