# HOUSE

#### Tuesday, January 28, 1919.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Boothby of Augusta.

Journal of previous session read and approved.

Papers from the Senate disposed of in concurrence.

The following bills, resolves and petitions were presented and, upon recommendation of the committee on reference of bills, were referred to the following committees:

#### Agriculture

By Mr. Washburn of Perry: An Act to provide for the collection of Agricultural Statistics by Assessors.

By Mr. Bradford of Turner: Resolve making an appropriation for the continuation of agricultural investigations by the Maine Agricultural Experiment Station at Highmoor Farm.

# Appropriations and Financial Affairs

By Mr. Burns of Eagle Lake: Resolve in favor of building additions to the Northern Maine General Hospital, Eagle Lake.

By Mr. Barnes of Houlton: Resolve in favor of the Madigan Memorial hospital.

## Education

By Mr. Varney of Jonesboro: Petition of L. E. Howes and nine others of Highland Plantation relative to the interest on wild land school fund.

By Mr. Dunning of Charleston: Resolve for aid in making addition to and improvements on the East Corinth Academy.

By Mr. Hammond of Van Buren: Resolve in favor of Van Buren College for maintenance and the purchase of equipment, and installation of electrical lighting.

By Mr. Bradford of Turner: Resolve making an appropriation for the rebuilding of the dormitory at Leavitt Institute.

By the same gentleman: An Act relating to leasing the shores in the Penobscot river belonging to the Penobscot tribe of Indians.

By Mr. Hammond of Van Buren: An Act to exempt certain public bonds from taxation. (500 copies ordered printed.)

By Mr. Garcelon of Auburn: An Act to amend Section 13 of Chapter 10 of the Revised Statutes, relating to the assessment of taxes. (500 copics ordered printed.)

#### Ways and Bridges

By Mr. Burns of Eagle Lake: Resolve appropriating money to aid the town of Eagle Lake to open farm lands for settlement. (500 copies ordered printed.)

By the same gentleman: Petition of John M. Brown and others in favor of same.

By Mr. Clifford of Reed Plantation: Resolve in favor of the repair of a road in Bancroft Plantation. (500 copies ordered printed.) By Mr. Daigle of Madawaska: Resolve appropriating money to aid in the construction of the sub-structure of a highway bridge over the St. John river between the towns of Madawaska, Me., and the city of Edmundston. New Brunswick.

By Mr. Pike of Eastport: Resolve to reimburse the city of Eastport for expenditure incurred in building a new section of the bridge connecting Perry and Eastport, and to aid in the repair of said bridge.

By Mr. Washburn of Perry: Resolve to aid in repair of road in the town of Robbinston.

By the same gentleman: **Resolve** to aid in repair of road in the town of Alexander.

#### Orders

On motion by Mr. Allan of Portland, it was

Ordered, that the use of the hall of the House of Representatives be granted to the Armenian Relief Commission of Maine, Thursday evening, Jan. 30th, for a public lecture on Armenian relief.

On motion by Mr. Allan of Portland, it was

Ordered, the Senate concurring, that the Committee on Taxation be authorized and directed to inquire into the expediency of the enactment of an Income Tax Law, similar to the laws of Massachusetts and Wisconsin, and to report by bill or otherwise.

On motion by Mr. Pattee of Harmony, it was

Ordered, that the State House Associates be granted the use of the hall of the House of Representatives on the evening of Wednesday, Feb. 5th, 1919, for the exhibition of Maine Industrial and Game stereopticon views and for the entertainment of the members of the 79th Legislature.

On motion by Mr. Maher of Augusta the rules were suspended and unanimous consent was given, to receive at this time the following resolution: Whereas, that veteran unit, the 26th Division, popularly known as the "Yankee Division" is about to return to the New England it has loved and honored, be it

Resolved, That mindful of the valorous record, appreciative of the heroic deeds, conscious of the imperishable fame and slightly expressive of the unutterable pride and love of the people of Maine for the sons of this State, both those who have given and those who have offered their all that just freedom might endure, there be named a delegation consisting of His Excellency, the Governor of this State, the living ex-Governors, the President of the Senate and Speaker of the House, the chief justice, the adjutant general of this State, and that this delegation be charged to meet and welcome in behalf of the people of Maine their returning sons upon their arrival at Boston.

The foregoing resolution was unanimously adopted by a viva voce vote and was sent up for concurrence.

On metion by Mr. Cochrane of Monmouth. it was

Ordered, the Senate concurring, that a joint committee of three on the part of the House, with such as the Senate may join, be appointed by the Chair to prepare and submit resolutions expressing appreciation of the courtesy of the Chief Executive in making the members of the Legislature his guests at the recent Efficiency Conference.

The SPEAKER: The Chair will nominate that committee later.

On motion by Mr. Lanpher of Sebec. it was

Ordered, that the Speaker of the House be directed to procure a typewriter and typewriter operator for the balance of the present legislative session.

# Orders of the Day

On motion by Mr. Lausier of Biddeford, the resolve appropriating money for the memorial at Biddeford was taken from the table; and on further motion by the same gentleman, it was referred to the committee on military affairs.

On motion by Mr. Sawyer of Fort Fairfield, the bill relating to public health was taken from the table, and on further motion by the same gentleman, it was referred to the committee on public health.

On motion by Mr. Barnes of Houlton, the bill granting liens to scalers was taken from the table and on further motion by the same gentleman it was referred to the committee on legal affairs.

On motion by Mr. Allan of Portland, the bill relating to the tenure of office of county treasurers was taken from the table and on further motion by the same gentleman it was referred to the committee on judiciary.

On motion by Mr. Allen of Sanford, the bill to amend Section 5 of Chapter 118 of the Revised Statutes, relating to fees of sheriffs and their deputies, was taken from the table and on further motion by the same gentleman was referred to the committee on judiciary.

On motion by Mr. Baxter of Portland the rules were suspended and unanimous consent was given to present at this time an order out of order as follows:

Ordered, that the use of the hall of the House of Representatives be granted the judiciary committee for the afternoons of Wednesday and Thursday of this week.

The order received a passage.
