#### HOUSE

#### Thursday, Jan. 30, 1919.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. H. S. Dow of Gardiner.

Journal of previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Ordered, the House concurring, that a committee on the part of the Senate, with such as the House may join, be appointed a committee to make arrangements for a reception to be tendered the Commanding General of the Northeastern Department, Major-General Clarence R. Edwards, formerly commanding officer of the "Yankee Division."

This order comes from the Senate read and passed, with the following committee appointed: Senators Gannett of Kennebec, Deering of York, Davies of Cumberland, Creighton of Knox, Peacock of Washington, and Dearth of Penobscot. The Chair will appoint on the part of the House. Messrs. Garcelon of Auburn, Sawyer of Fort Fairfield, McLeary of Farmington, Mason of Ellsworth, Perkins of Boothbay Harbor, Stanley of Dixfield, Flint of Monson, Peabody of Richmond, Millett of Palmyra and Buzzell of Belfast.

The order then received a passage in concurrence.

Mr. WILLIAMS: I accept the amendment.

Ordered, the Senate concurring, that 500 additional copies of House bill No. 20 "An Act for the preservation, perpetration and increase of the forests of the State of Maine," be printed for the use of the members of the Legislature.

On motion by Mr. Smith of Skow-hegan, it was

Ordered, that 500 additional copies of House bill No. 3, being an Act to provide for the registration of legislative counsel and agents, be printed.

On motion by Mr. Smith of Skowhegan, it was

Ordered, that 500 additional copies of House bill No. 2, an Act to provide for the election of road commissioners of towns, be printed.

#### **Reports of Committees**

Mr. Clifford from the committee on claims to which was referred resolve in favor of Francois X. Belleau, reported that the same be referred to the committee on legal affairs.

The report was accepted.

Mr. Holley from the commmittee on appropriations and financial affairs, to which was referred resolve in favor of W. W. Greaton, for services as Document Clerk at the organization of the 79th Legislature, reported that the same "ought to pass."

The report was accepted, and the resolve tabled for printing under the joint rules.

Mr. Garcelon from the committee on legal affairs to which was referred bill an Act to repeal Chapter 288 of the Public Laws of 1917 relating to the keeping and sale of dynamite, powder and other explosives, reported that the same "ought to pass."

The report was accepted.

Mr. BARNES of Houlton: Mr. Speaker, the act in your hands is one of the war emergency measures of two years ago, fettering and hampering to some considerable extent dealers in explosives. I move that the rules be suspended and that the bill now have its three readings and passed to be engrossed.

Mr. WILSON of Portland: May I inquire if that bill has the emergency clause attached to it?

The SPEAKER: The Chair will state that it has not.

Mr. WILSON: Mr. Speaker, I cannot see any object in rallroading it through at this rate. I understand it will not take effect until 90 days after adjournment in any event.

The SPEAKER: The motion has been made and seconded that the rules be suspended and that this bill be given its three several readings at the present time and passed to be engrossed.

A viva voce vote being taken, the motion was carried, and the bill was given its three several readings and passed to be engrossed.

#### Orders of the Day

Mr. O'LEARY of Bangor: Mr. Speaker, the resolve in favor of the city of Bangor reimbursing it for aid for soldiers' dependents was referred to the committee on claims. I understand that there are similar resolves that have been referred to the committee on military affairs. I move the resolve be recalled from the committee on claims.

The SPEAKER: The Chair will inquire of the gentleman from Bangor (Mr. O'Leary) if this has been referred and is in the hands of the committee?

Mr. O'LEARY: I believe it is, Mr. Speaker.

The SPEAKER: The Chair will state that in its opinion the best way would be to have that committee report it back to the Legislature for reference to another committee.

Mr. O'LEARY: I will submit an order to that effect, Mr. Speaker.

On motion by Mr. Allan of Portland, it was voted to take from the table House Document No. 49, An Act to amend Section 82 of Chapter 115 of the Revised Statutes, as amended by Chapter 136 of the Laws of Maine for 1917, relative to support of debtors in jail; and on further motion by the same gentleman it was referred to the committee on legal affairs.

Mr. BARNES of Houlton: Mr. Speaker. I tabled a bill An Act authorizing the Oxford Electric Company to discontinue the operation of its road and 'o dispose of its franchises and property. The question involved in that bill is a close question of law, whether or not a corporation chartered to generate electricity-sell electricity and run a street railway-can be relieved of its duty to the public to run a street railway, abandon its street railway business, sell its rails and sleepers, and continue to develop and sell electricity. The suggestion of the committee of reference was that it go to the committee on public utilities. I move, Mr. Speaker, that it be referred to the committee on judiciary.

The motion was agreed to.

On motion by Mr. Bragdon of Perham, the House voted to reconsider its action whereby An Act to amend Section 45 of Chapter 117 of the Revised Statutes to increase the clerk hire in certain county offices in Aroostook county, was referred to the committee on salaries and fees; and on further motion by the same gentleman it was tabled for printing pending reference.

On motion by Mr. Bragdon of Perham, the House voted to reconsider its action whereby An Act to amend Section 40 of Chapter 117 of the Revised Statutes, to increase the compensation of the clerk of courts in Aroostook county," was referred to the committee on salaries and fees; and on further motion by the same gentleman it was tabled for printing, pending reference.

On motion by Mr. Bragdon of Perham, the House voted to reconsider its action whereby An Act to increase the annual salary of the register of deeds for Aroostook county, Southern Registry, was referred to the committee on salaries and fees; and on further motion by the same gentleman it was tabled for printing, pending reference.

On motion by Mr. O'Leary of Bangor, the House voted to suspend the rules and receive out of order the following order:

Ordered, the Senate concurring, that the resolve in favor of the city of Bangor reimbursing it for aid furnished dependents of soldiers, now referred to the committee on claims, be recalled, and referred to the committee on military affairs. The order received a passage.
