Tuesday. February, 4, 1919.
The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Layton of Augusta.

Journal of previous session read and approved.

Papers from the Senate disposed of in concurrence.

Orders

Mr. Rounds of Portland presented the following order:

Ordered, that the State Treasurer be requested to furnish forthwith a statement of the receipts and expenditures of all public money, which should have been published at the commencement of the 79th Legislature, in accordance with the provisions of Section 4, Article V, part

fourth, of the Constitution of Maine.

Mr. ALLAN of Portland: Will the
gentleman (Mr. Rounds) explain
what he is trying to get at?

The SPEAKER: Does the gentleman from Portland, Mr. Rounds, wish to make any statement as to the intention of this order?

Mr. ROUNDS: One of the provisions of the Constitution of Maine has not been complied with. every member of this House would like to know the financial condition of the State of Maine at the beginning of this session. I have been here going on six weeks and I have not been able to find out. I have been to the different Departments and I have found out some things, but I would like a clear statement in accordance with the provisions of the Constitution. Therefore, I present this order at this time.

A viva voce vote being taken, the order received unanimous passage, and was sent up for concurrence.

Reports of Committees

Mr. O'Leary, from the Committee on Appropriations and Financial Affairs, to which was referred Resolve in favor of the Bangor Anti-Tuberculosis, reported that same be referred to the Committee on State Sanatoriums.

Report was read and accepted and sent up for concurrence.

Mr. Holley, from same committee, reported "ought to pass" on resolve in favor of William R. Roix.

Report was read and accepted and resolve ordered printed under joint rules.

Mr. Lanpher, from the Committee on Legal Affairs, reported same on bill "An Act to amend Sections 11 and 13 of Chapter 6 of the Revised Statutes relating to enrollment of voters for primary elections."

The SPEAKER: The Chair will state that this bill appears to be reported in the original draft and has already been printed. Unless somebody moves suspension of the rules so that this bill can take its readings at this time, it will automatical-

ly be tabled for printing under the joint rules.

On motion by Mr. Garcelon of Auburn, the rules were suspended, and the bill given its two several readings at this time.

Mr. ROUNDS of Portland: I do not think it wise, Mr. Speaker, to rush these bills through, inasmuch as there is no general primary election until a year from now. Therefore, I would like to have the bill tabled until I can investigate it.

A viva voce vote being taken, the bill was tabled, pending commitment to the committee on bills in the third reading.

Mr. ALLAN from the Committee on Taxation reported "ought to pass" on bill "An Act relative to the taxation of money deposited in banks outside the State."

The report was read and accepted and the bill ordered printed under the joint rules.

The SPEAKER: The Chair feels that perhaps at this time it is not out of place to state that when a

bill is introduced and sent to a committee and reported out in the original draft, it would save expense to the State if the rules were suspended and the bill given its reading at that time in order to save double printing of the same bill which has already been printed and is in the hands of the members of the Legislature. The Chair simply makes this suggestion.
