#### HOUSE

Tuesday, March 4, 1919.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Gibson of

Journal of previous session read and approved.

(Mr. Barnes at this point assumed the Chair.)

Papers from the Senate disposed of in concurrence.

From the Senate: Resolve in favor of Esther M. Giles.

This resolve was passed in the House and sent up to the Senate, the Senate voting to non-concur. In the House, on motion of Mr. Perkins of Boothbay Harbor, the House voted to insist on its action, and a committee of conference was appointed. It was then sent up to the Senate for concurrence and the Senate voted to adhere.

Mr. PERKINS of Boothbay Harbor: Mr. Speaker, I move that the House insist upon its action, and I wish to state that there is a bill before the Legislature, introduced by the senator from Cumberland, Senator Gurney, relative to aid for dependent soldiers and sailors; and, if that bill becomes a law, Mrs. Giles will have no claim against the State of Maine as a matter of law, because that repeals next to the last section of Chapter 276. I wish simply to say this, that Mrs. Giles' husband was killed in action in France on the 3rd day of last October. She has, I believe, a claim against the State of Maine which should be paid. She is left a widow with a small child, and I feel that the House should insist upon its former action, and give this widow of one of our gallant veterans at least a hearing. I move, Mr. Speaker, that we insist on our action. (Applause.)

The motion prevailed, and the House voted to insist on its former action, appointing a committee of conference.

From the Senate: An Act to extend the charter of the Salisbury Cove Water Company. Returned from the Senate with Senate Amendment A.

On motion by Mr. Phillips of Bar Harbor, the House voted to reconsider its vote whereby it passed this bill to be engrossed. On further motion by the same gentleman Senate Amendment A was adopted; and on further motion by the same gentleman, the bill as amended by Senate Amendment A was passed to be engrossed.

From the Senate: An Act to amend Sections 3 and 5 of Chapter 37 of the Revised Statutes, regulating the sale of milk.

This comes from the Senate as amended by Senate amendments  ${\bf A}$  and  ${\bf B}.$ 

On motion by Mr. Maher of Augusta, the House voted to reconsider its action whereby this bill was passed to be engrossed, and on further motion by the same gentleman the bill and amendments were tabled pending acceptance of the amendments.

HOUSE JOINT MEMORIAL No. 19. Introduced by Mr. Dennis, and read February 17, 1919.

To the Honorable Senate and House of Representatives of the United States of America, in Congress assembled:

We your memorialists, the House of Representatives of the state of Oregon, the Senate concurring, respectfully represent that:

Whereas, there is now pending in the Congress of the United States a bill entitled "A bill to provide for the taking over, improvement, relocation, construction and maintenance of a system of national highways and state highways, designed to facilitate the movement of troops, equipment, munitions and supplies, and to promote the general welfare of the people of the United States," numbered S. 2470, introduced by the Honorable George E. Chamberlain, United States senator from Oregon; and

Whereas the passage of said bill by the Congress would greatly inure to the benefit and advantage of the United States of America; now, therefore, be it

Resolved, by the House of Representatives of the state of Oregon, the Senate concurring, that the legislative assembly of the state of Oregon respectfully requests the Congress of the United States to pass said Senate Bill No. S. 2470, and that each of the United States senators and representatives from the state of Oregon be respectfully requested to use all their best endeavors to that end.

Resolved, that the secretary of state be and hereby is authorized and directed to transmit a copy of this memorial under the seal of his office to every member of the Oregon delegation in Congress, and to the presiding officer of the Senate of the United States, and to the presiding officer of the House of Representatives of the United States, and to the secretary of state of each state in the United States of America, to be delivered to the Legislature of the said states with the request that this resolution be concurred in.

An Act to amend Section 38 of Chapter 33 of the Revised Statutes, as amended by Chapter 219 of the Public Laws of 1917, relating to the protection of deer.

An Act to amend Sections 2 and 6 of Chapter 66 of the Public Laws of 1917, relating to non-resident fishing licenses.

An Act to provide for retiring and pensioning employees of the State of Maine.

An Act to amend Section 91 of Chapter 53 of the Revised Statutes, relating to the annual statement of conditions of insurance companies, and providing a penalty for neglect to file the statement.

An Act to amend Section 11 of Chapter 211 of the Private and Special Laws of 1895, as amended by Chapter 101 of the Private and Special Laws of 1909 and Chapter 146 of the Private and Special Laws of 1915, relating to clerk hire in the Bangor municipal court.

An Act to amend Section 26 of Chapter 70 of the Revised Statutes, relating to the time of payment of legacies

An Act to amend Sections 42 and 43 of Chapter 64 of the Revised Statutes, relating to the publication of ancient vital statistics.

Mr. BERRY of Waterville: Mr. Speaker, I would like to inquire, through the Chair, if the Resolve for the appointment of a committee for the purpose of celebrating the glorious victory for the national prohibition amendment carries with it

any money appropriation. As I remember, when it came into the House it was \$200.

The SPEAKER pro-tem: It is the opinion of the Chair that it does not.

Mr. BERRY of Waterville: If it does not, all right. If it does, I wish it laid on the table.

#### Orders of the Day

On motion by Mr. Rounds of Portland, it was voted to take from the table Resolve for monument commemorating the 100th anniversary of all wars since Maine became a State; and on further motion by the same gentleman the Resolve was referred to the committee on appropriations and financial affairs.

On motion by Mr. Perkins of Boothbay Harbor, it was voted to take from the table An Act to amend Section 71 of Chapter 45 of the Revised Statutes, relative to use of seines in traps, and on further motion by the same gentleman it was referred to the committee on sea and shore fisheries.

On motion by Mr. Murchie of Calais it was voted to take from the table House Document No. 233, An Act to amend Chapter 25 of the Revised Statutes, as amended, relative to the State Highway Commission; and on further motion by the same gentleman it was referred to the committee on ways and bridges as recommended by the committee of reference.

mittee of conference on bill An Act to amend Chapter 8 of the Revised Statutes, relative to the office of forest commissioner, Messrs. Cunningham of Patten, Murchie of Calais and Hussey of Blaine.

Mr. BERRY of Waterville: Mr. Speaker, I accept the Speaker's explanation that he thinks that the Resolve passed relative to the national prohibition celebration carries no money appropriation with it. However, if the Chair were mistaken and I should discover it, I give notice at this time that I will move tomorrow for reconsideration.

The SPEAKER pro tem: The announcement of the gentleman is accepted by the House.

Mr. ROUNDS of Portland: Mr. Speaker, Is that bill relative to the forest commissioner the one I had sent back or recommitted?

The SPEAKER pro tem: This bill was by the Senate referred to the committee on salaries and fees. By the House on February 25, in non-concurrence, it was referred to the committee on State lands and forest preservation; whereupon it was returned to the Senate. The Senate voted to insist on its former action and asked for a committee of conference and it appointed its committee of conference. The announcement made by the Chair was simply the names of the committee of conference on the part of the House.
