In compliance with an order of the House of Representatives, dated January 27, 1921, asking that there be filed within one week from that date an itemized account of the total cost to date of the garage that the Highway Commission is building, or having built, in Augusta, the cost of same and from what funds the money is taken. I send herewith such itemized account, which shows that the total net expenditure to January 24, 1921, for such purpose was \$184,343.-

The House of Representatives. Augusta, Maine.

Sirs: In compliance with order under date of January 27, we beg to state that the estimated total cost of garage now being constructed in Augusta is \$219.640.19.

Equipment so far purchased consists of a one thousand gallon gasoline tank and a pump and five threebarrel lubricating outfits with pumps. The gas tank has been buried in the yard outside of the building and is ready to be connected with the pump. The equipment outlined above, gas and oil tanks and pumps. cost \$1,363.05.

No machinery has been purchased. The State Highway Commission is planning to pick up second hand machinery from time to time that is suitable for garage work and which can be bought at a low price. Needed equipment will probably cost from three thousand to four thousand dollarg

The size of the building is as fol-

One wing, inside dimensions, 151 feet by 74 feet, 6 inches, consisting of basement and one floor; the other wing is 201 feet by 49 feet, inside dimensions, consisting of a basement and one floor. The building is so laid out that there are entrances from three different grade levels and a ramp from the basement of the first wing to the basement of the second wing, which is on the level with the first floor of the first building, eliminates the need of an elevator to move tracks from one part of the building to the other.

The estimated capacity of the building is for one hundred and sixty trucks, including a chance for repairing about twenty trucks at one time. It is believed if the building were used solely for storage that two hundred trucks and automobiles could be stored in it.

State Highway Commission. ROUNDS of Portland: Mr. Speaker, I would like to ask whether that was a cost-plus contract, and if that will include the whole of it? I do not like to have this thing go on and not know how much we are going to pay. It looks to me, as I understand a cost-plus contract, that we do not know whether it is going to be \$219,000 or \$250,000. Then they tell us that they are going to buy second hand machinery. I do not think that kind of machinery for the State of Maine is of any benefit. I feel we should have new machinery, but that we should not pay cost plus ten per cent. I think we should do something and not have it lie on the table too long.

Reports of Committees

Mr. Ho.ley from the Committee on Appropriations and Financial Affairs, reported on Resoive in favor of Benjamin A. Swasey, "Ought not to pass as the subject matter is covered in another Resolve."

Report was read and accepted and sent up for concurrence.

Passed to Be Engrossed

House 49. An act amending Section 4 and 6 of Chapter 262 of the Public Laws of 1917, relating to fees of city clerks.

Report of committee on bills in third reading accepted.

Mr. Rounds of Portland offered House amendment A as follows:

House Amendment A

"Section six of Chapter two hundred sixty two of the Public Laws of nineteen hundred and seventeen is hereby amended by adding after the word 'dollar' in the seventh line thereof, the following words: 'twenty five cents of which shall be paid to the city cierk for issuing said new certificate,' so that said section as amended shall read as follows:

'Sec. 6. When an engineer or fireman shall apply for a renewal of his license for the same grade, the presentation of the attested copy of the original certificate shall be considered sufficient evidence of his title to renewal, which certificate shall be retained by the examiner upon the official files as the evidence upon which the license was renewed, and a new certificate shall be issued upon payment of the fee of one dollar, twenty five cents of which shall be paid to the city clerk for issuing said certificate, unless such license shall be forfeited or unless facts shall have come to the knowledge of the examiner, which would render a renewal improper. In such case the applicant shall be entitled to a hearing before the examiner. In case of loss or destruction of applicant's certified copy of his license, the city clerk shall by direction of the examiner, issue to the applicant a duplicate attested copy, upon payment of the usual fee of twenty five cents."

On motion by Mr. Rounds of Portland, the bill was tabled pending third reading.

Orders of the Day

On motion by Mr. Smith of Skowhegan, the rules were suspended and the following resolve introduced:

Resolve in favor of the widow of Governor Parkhurst.

Resolved that there be paid to the widow of the late Governor Frederic H. Parkhurst, the salary that the State would have paid to Governor Parkhurst had he served the fuil term for which he was elected.

The Governor and Council are hereby authorized and directed to draw their warrant in favor of Dorothy W. Parkhrust for the full salary that would have been paid Governor Parkhrust had he served his full term of office.

On further motion by the same gentleman, the resolve had its two several readings, under suspension of the rules, and was passed to be engrossed.

On motion by Mr. Hinckley of South Portland, it was voted to take from the table order relative to reorganization of State departments; and on motion by Mr. Winter of Auburn, the order received passage.

On motion by Mr. Winter of Auburn, it was voted to take from the table bill, An Act to consolidate the library laws; and on further motion by the same gentleman this bill was referred to the joint committee composed of the committee to be appointed under the House order to reorganize and consolidate the several State departments, and the joint standing committee on Library.

The SPEAKER: The Chair would take this opportunity to suggest to the

members of the House that, under the regulations of the House, of the present session at least, immediately upon the close of the session the pages clear the room. On many an afternoon this room is used for purposes other than the regular session of the House. The members of the House have been furnished with keys to the desks ar which they sit and property of members of the House worthy of presrvation should be placed within the desks or removed from the room; otherwise such property is very liable to be lost in the cleaning of the desks.

On motion by Mr. Maher of Augusta, it was voted to take from the table bill, An Act to regulate the payments of appropriations for the care, treatment, support, treatment of persons in charitable or benevolent institutions not wholly owned or controlled by the State; and on further motion by the same gentleman, the bill was re-tabled and 500 copies ordered printed.

The SPEAKER: Another notice the Chair will give that on February 9. Wednesday, tomorrow, at 8 o'clock in the evening, in this hall, William F. Dawson gives his lecture on Mt. Katahdin, and it is illustrated by pictures which are said to be well worth the attention of anyone. The public generally is invited. The members of the House will take notice thereof.

The Chair wishes to make another suggestion. Recommendations by the Budget committee, and recommendations which are in the budget, do not necessarily pre-suppose an appropriation for the particular institution or object for which the Budget recommends. It is altogether better, probably, that resolves be introduced for constituents of each of you, looking toward appropriations, that they may not be overlooked when the appropriation bills and the tax acts are drawn.

It is further necessary to suggest that if any of these required appropriations are expected to be available for expenditure before June 30 of this year, that the emergency clause must be attached, and further that there can probably be no objection to writing the resolve in one sheet, rather than

two, one for the first fiscal period and the other without the emergency.

It is impossible for the clerk to make up his record unless members obey the rule that their names be added at the bottom on the outside of

any paper which they introduce in the House.

On motion by Mr. Emery of Buxton, Adjourned until 10 o'clock tomorrow morning.
