#### HOUSE

Friday, February 11, 1921.

The House met according to adjournment and was called to order by the Speaker.

Prayer by Chaplain Frank L. Phalen, the National Soldiers' Home, Maine.
Journal of previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Resolve in favor of the widow of Governor Parkhurst. In the House this resolve was passed to be engrossed.

This comes from the Senate referred to the Committee on appropriations and financial affairs in non-concurrence with the action of the House.

On motion by Mr. Smith of Skowhegan, the House voted to recede from its former action and concur with the Senate in referring the resolve to the Committee on Appropriations and Financial Affairs.

From the Senate: Resolve in favor of the Home for Feeble Minded.

This comes from the Senate referred to the committee on School for Feeble Minded.

In the House on motion of the gentleman from Belfast, Mr. Buzzell, it was voted to refer to the Committee on Ways and Bridges in non-concurrence with the action of the Senate, owing to the subject matter of the bill.

From the Senate: Ordered, the House concurring that a joint select committee on the part of the Senate, with such as the House may join, be appointed to consider the Governor's message and report a reference of its several subjects to appropriate committees.

The SPEAKER: The Chair craves the pardon of the House for again and again making suggestions that seem to be, perhaps, encumbering the record by being made so many times. All appropriations of money and requests for appropriations for money to be expended between January 1, 1921 and June 30, 1921, must, to be effective, be accompanied by an emergency clause. This aparently is self evident. In the later days of the session it will encumber the record. double the work, and lead possibly to more or less of error if these papers pass at this time without the emergency clause attached. It is putting a large burden upon the shoulders of the committee on appropriations and financial affairs for the members of the House to neglect to attend to this duty themselves. Some day, when there is a larger attendance the Speaker will probably repeat more or less of the purport of this suggestion.

 $\mathbf{of}$ Mr. ROUNDS Portland: Mr. Speaker, I understand we have a clerk to make out emergency acts or any acts or resolves we see fit to make. Many members, perhaps, do not know just how to make them out. Now why not send them down to the man who is employed for that purpose and have him put on the right clause for an emergency act so there will be no question at the end of the session about it. The appropriations committee, it seems to me, ought to fix that without putting it up to the members who do not know about the emergency. I had one, and I think I came to you, Mr. Speaker, to have it straightened out. I think it would be right for the committee to send to our clerk. He will not have much to do after the special resolves are put in.

The SPEAKER: The House hears the suggestion of the gentleman from Portland (Mr. Rounds), and will bear in mind that, at the expense of the State, a man is at your service to assist in drafting bills and resolves.

Same gentleman from same committee reported "Ought to pass" on Bill "An Act authorizing Maine General hospital to increase number of directors to twenty-four."

Same gentleman from same committee reported same on Bill "An Act to extend An Act entitled 'An Act to incorporate the Odd Fellows Home of Maine.'"

Reports were read and accepted and the bills ordered printed under the Joint Rules.

The same gentleman from the same committee on Bill "An Act to amend Section 3 of Chapter 99 of the Private and Special Laws of 1915, creating the office of corporation counsel for the city of Portland," reported the same in a new draft under same title and that it "Ought to pass."

Report was read and accepted and the new draft orders printed under the Joint Rules.

Same gentleman from the same committee on Bill "An Act amending Section 25 of Chapter 30 of the Revised Statutes relating to appointment and duties of inspector of buildings," reported that the same be referred to the Portland delegation.

Report was read and accepted and sent up for concurrence.

Mr. Viles from the committee of State Lands and Forest Preservation on Bill "An Act to amend Section 61 of Chapter 8 of the Revised Statutes as amended by Chapter 101 of the Public Laws of 1919 relative to the Maine Forestry District tax," 'reported the same in a new draft under title of "An Act to amend Sestion 61 of Chapter 8 of the Revised Statutes as amended by Chapter 104 of the Public Laws of 1919, relative to the Maine Forestry District tax," and that it "Ought to pass."

Report was read and accepted and the new draft ordered printed under the Joint Rules.

Mr. Spear from the committee on Towns reported "Ought to pass" on Bill "An Act to repeal acts incorporating the town of Concord."

Same gentleman from same committee reported same on Bill "An Act creating West Paris Village Corporation."

The reports were accepted and the bills ordered printed under the Joint Rules.

### First Reading of Printed Bills and Resolves

House 14. An act to authorize the American Realty Company to conconstruct and maintain a dam across the St. John River in Township Nine, Range Eighteen, W. E. L. S., Somerset County, Maine, and to locate, erect and maintain piers and booms in said river above said dam.

#### Passed to Be Engrossed

House 1. An act additional to and amendatory of Chapter seven of the Revised Statutes, relating to elections. Mr. MAHER of Augusta: Mr. Speaker, is that the bill relative to absentee voting?

The Speaker: It is.

Mr. MAHER: I would like to have that tabled, as I purpose to offer an amendment.

Thereupon the bill and report of the committee on bills in the third reading were tabled, pending acceptance of report.

Senate 28. An act to amend Sections one and three of Chapter 116 of the Revised Statutes, relating to duties payable by public officers.

#### Orders of the Day

On motion by Mr. Smith of Skowhegan, the House voted to reconsider its action whereby the Dorothy W. Parkhurst resolve was referred to the committee on appropriations and financial affairs; and on further motion by the same gentleman that resolve was tabled.

On motion by Mr. Granville of Parsonsfield, it was voted to suspend the rules and that gentleman was permitted to introduce out of order bill "An act relative to motor vehicles and the law of the road, and to revise and amend Chapter 28 of the Revised Stat-

utes and acts amendatory thereof and additional thereto"; and on further motion by the same gentleman the bill was referred to a joint special committee of Judiciary and Ways and Bridges and 300 copies ordered printed.

The SPEAKER: The Chair presents at this time the order originating in the House as follows:

Ordered, the Senate concurring, that a committee of three on the part of the House and such number on the part of the Senate as it may determine, be appointed to consider the advisability of establishing a restaurant in the State House and report by bill or otherwise.

In the Senate the order was given passage and Messrs. Gould of Aroostook and Adams of Kennebec were appointed thereon on the part of that branch.

The House joins therewith, Messrs. Warren of Portland, Elmore of Camden and Viles of Augusta.
