HOUSE

Thursday, March 3, 1921.

The House met according to adjournment and was called to order by the Speaker.

Prayer by the Rev. Mr. Layton of Augusta.

Journal of previous session read and approved.

Papers from the Senate disposed of in concurrence.

From the Senate: Bill "An act to amend sub-paragraph A" of paragraph two of Section seven of Chapter 188 of the Public Laws of 1917, relating to the duties of superintendents of schools." This was passed to be engrossed in the House February 25

Comes from the Senate passed to be engrossed as amended by Senate Amendment A in non-concurrence.

In the House, on motion by Mr. Cordwell of Westbrook, that body voted to reconsider its action whereby the bill was passed to be engrossed

(Senate amendment A read by the Clerk.)

The Speaker: The amendment, the Chair will state for the benefit of the gentlemen is solely due to the fact that the subject matter was treated of in a session subsequent to 1916, so that it was deemed better to refer to the particular act subsequent to 1916 rather than the Revised Statutes.

On further motion by Mr. Cordwell of Westbrook, the House voted to adopt Senate amendment A; and en further motion by the same gentleman the bill was passed to be engrossed as amended by Senate Amendment A in concurrence.

From the Senate: Bill "An act to amend Section five of Chapter 117 of the Revised Statutes, as amended by Chapter 170 of the Public Laws of 1917, relating to the salaries of justices of the Supreme Judicial Court." This was indefinitely postponed in the House March 1 in non-concurrence.

Comes from the Senate with that body insisting on its action and asking a committee of conference with the following conferees appointed on its part:

Messrs. Farrington of Kennebec,
Thombs of Penobscot,
Allen of York.

In the House, on motion by Mr. Brewster of Portland, it was voted to join the committee of conference.

The SPEAKER: The conferees on the part of the House will be later named.

By Mr. Forbes of Paris: Remonstrance of L. C. Bates and 41 others of Paris against the "Barwise Sunday Bill."

Agriculture

By Mr. Austin of South Berwick: Bill "An act to repeal Chapter 18 of the Resolves of 1917, relating to animal industry.

Judiciary

By Mr. Moody of York: Remonstrance of E. J. Allen and 36 others against the granting of a water district in the town of Wells.

By Mr. Smith of Waterboro: Remonstrance of R. S. Bragdon and 36 others against same.

By Mr. Rounds of Portland: Bill "An act to amend the law relating to profiteering."

By the same gentleman: Resolution calling upon the people of this State to display the National colors annually on "Mother's Day" the second Sunday in May in honor of the homes of our State and country.

Judiciary and Military Affairs

By Mr. Rounds of Portland: Bill "An act to create the National Guard pay fund." (1500 copies ordered printed.)

Legal Affairs

By Mr. Rounds of Portland: Bill "An act relative to the registration

of persons, firms and corporations designing to install wires or apparatus for electric lights, heat, or power purposes.

By Mr. Crabtree of Island Falls: Bill "An act to enable cities and towns to recover from the owner of property the expense of putting out a fire under certain conditions." (500 copies ordered printed.)

Mr. CRABTREE of Island Falls: Mr. Speaker, I move that we reconsider the vote whereby this was referred to the committee on Legal Affairs and that the same be referred to the committee on Mercantile Affairs and Insurance.

The SPEAKER: The parliamentary situation is this, it not having vet been referred. The title of the bill is "An act to establish cities and towns to recover from the owner of property the expense of putting out a fire under certain conditions." The committee on reference of bills made up of two from the Senate and three from the House suggests reference to the committee on Legal Affairs and suggests the printing. They do not refer it. It is in the power of the House to refer to any committee: and the gentleman from Island Falls (Mr. Crabtree) moves that this bill he referred to the committee on Mer cantile Affairs and Insurance.

A viva voce vote being taken the motion failed of passage, and a further viva voce vote being taken, the bill was referred to the committee on Legal Affairs and 500 copies ordered printed.

By Mr. Rogers of Jonesport: Remonstrance of O. W. Leighton and 40 others of Jonesport against same.

By the same gentleman: Remonstrance of R. W. Beal of Jonesport and 19 others against same.

By Mr. Case of Lubec: Remonstrance of George W. Porter and 39 others of Cutler against same.

Reports of Committees

Mr. Gardiner from the joint committee on Judiciary and ways and bridges, on bill, "An Act relative to State highways," reports that the same be printed and recommitted to the joint committee on judiciary and ways and bridges.

The report was accepted, the printing ordered and the bill was recommitted to the joint committee on judiciary and ways and bridges.

Mr. Holley from the committee on appropriations and financial affairs on Resolve appropriating money to aid the town of Fort Kent for the construction of a stone work on the Fish river to prevent it from wearing out any more land, reporting that the same be referred to committee on ways and bridges.

Mr. Wing from the committee on judiciary reported "Ought not to pass" on Bill, "An Act to amend Section 3 of Chapter 111 of the Revised Statutes of 1916 relating to persons exempted from serving as jurors."

Same gentleman from same committee reported the same on Bill. "An Act to amend Chapter 465 of the Private and Special Laws of 1868 relative to the election of superintending school committee and superintendent of schools in the city of Lewiston." Also in regard to the method of taxation in connection with maintenance of city schools."

Mr. Murchie from the same committee reported the same on Bill, "An Act to provide for retiring and pensioning employees of the State of Maine"

Mr. Buzzell from same committee reported the same on Bill, "An Act to provide for the enforcement of Chapter 159 of the Public Laws of 1917 relating to cruelty to animals."

Mr. Murchie from same committee reported the same on Bill, "An Act to make uniform the law of sales of goods."

Mr. Croxford from the committee on public health reported the same on Resolve in favor of the State Department of Health.

Mr. Snipe from the same committee reported the same on Bill, "An Act to provide for the purity of ice cream and sherbet offered for sale."

Reports were read and accepted and sent up for concurrence.

Mr. Hinckley from the committee on judiciary reported "Ought to pass" on Bill, "An Act to authorize the Boston and Maine Railroad to acquire the property and franchises of or consolidate with any of its subsidiaries not already acquired by or consolidated with, under and by virtue of Chapter 186, Private and Special Laws of 1915, and Acts amending and extending the same."

Mr. Cole from the same committee

reported the same on Bill, "An Act validating and making legal a meeting of the stockholders of the American Warp Drawing Machine Company in amending and enlarging the purposes of corporation."

Reports were read and accepted and the bills ordered printed under the joint rules.

Mr. Wing from the same committee reported the same on Bill, "An Act to amend Section 41 of Chapter 51 of the Revised Statutes so as to provide for the amendment of corporate purposes."

Report was read and accepted and the bill having already been printed, the rules were suspended and the bill had its two several readings.

Mr. Hinckley from the same committee reported ought to pass on Bill, "An Act to authorize the town of Bristol to pay certain obligations incurred by its citizens in opposing the division of said town."

Mr. Wing from the same committee reported the same on Resolve authorizing Michael Burns to bring suit against the State of Maine.

Mr. Gardiner from the same committee reported the same on Resolve in favor of commissioner of labor and industry and State factory inspector.

Mr. Fagan from the committee on legal affairs on bill An Act to amend charter of Home for Aged Men, reported the same in a new draft under title of "An Act to amend Chapter 133 of Private and Special laws of 1881, entitled 'An Act to incorporate the Mercantile Home for Aged Men Association,' as amended by Chapter 267 of Private Laws of 1883, which changed the name to Home for Aged Men," and that it ought to pass.

Mr. Willard from the same committee on Resolve in favor of York county issuing bonds reported the same in a new draft under title of "An Act relating to York county issuing bonds," and that it ought to pass.

Mr. Poore from the committee on public health reported ought to pass on Bill An Act to prohibit advertisements of cures or medicines relating to venereal diseases and certain sexual disorders.

Mr. Snipe from the same committee reported the same on Bill An Act for better care of the inmates of the State Prison and Men's Reformatory suffering from tuberculosis.

Reports were read and accepted, the bills and resolves ordered printed under the joint rules.

Mr. Croxford from the committee on public health reported ought to pass on Bill An Act to provide for return and cleansing of ice cream and sherbet containers.

Report was read and accepted and the bill having already been printed had its two several readings under suspension of the rules.

Majority report of the committee on judiciary reporting ought not to pass on Bill An Act to amend Chapter 201 of the Private and Special Laws of 1917, entitled "An Act to grant a new charter to the city of Auburn."

House 170: Resolve reimbursing the county of Kennebec for money expended in pursuing insane criminals escaping from Augusta State Hospital.

House 198: Resolve to reimburse the town of Mapleton.

Orders of the Day

The SPEAKER: Under orders of the day, the calendar for today is before the House.

Mr. ROUNDS of Portland: Mr. Speaker, does that refer to the heading "tabled and today assigned?"

The SPEAKER: The gentleman from Portland, Mr. Rounds, calls the attention of the House to the fact that Senate Doc. No. 59, bill, An Act relative to the price of the Maine Reports, is tabled and specially assigned

for consideration today. The Chair will recognize the gentleman from Portland, Mr. Rounds.

On motion by Mr. Rounds, the vote was reconsidered whereby this bill was passed to be engrossed.

The pending question being the adoption of Senate Amendment "A," in concurrence.

Mr. Rounds requested that Senate Amendment "A" be read.

The Speaker then read Senate Amendment "A," the effect of which is to increase the price of the volumes of Maine Reports from \$2.50 to \$3.00.

The question being on the adoption of Senate Amendment "A."

The amendment was adopted.

On further motion by Mr. Rounds, the bill as amended was passed to be engrossed.

The SPEAKER: Is there anything further to come before the House under orders of the day?

Mr. VILES of Augusta: Mr. Speaker, I move that the House reconsider its vote whereby the bill regarding moving picture films, which was received from the Senate this morning, was referred to the committee on judiciary.

The SPEAKER: The Chair will state that this bill is an act to create a board of censors to pass upon moving picture films offered for public exhibition in Maine. This came from the Senate, referred in that branch to the committee on judiciary. The House this morning has referred the bill to the committee on judiciary in concurrence with the Senate. The gentleman from Augusta, Mr. Viles, now moves that the House reconsider its vote whereby it referred this bill to the committee on judiciary in concurrence. Is that the pleasure of the House?

The motion was agreed to.

Mr. VILES: Mr. Speaker, I will now move that this bill be referred to the committee on judiciary and the committee on appropriations and fi-

nancial affairs, for the reason that this bill carries an appropriation.

The motion was agreed to, and the bill was referred to the committee on judiciary and appropriations and financial affairs in non-concurrence.

The SPEAKER: The Chair presents for the consideration of the House, under the heading of "tabled and unassigned," Senate Doc. No. 58, resolve to purchase history of Williamsburg, tabled pending its first reading, and the Chair announces that this matter has been presented to the committee on appropriations and financial affairs.

The resolve then received its first reading, and on motion by Mr. Dodge of Portland, was tabled pending its second reading.

The SPEAKER: The Chair presents for the consideration of the House. Senate Doc. No. 62, Resolve to purchase history of the town of York, tabled pending its first reading, and the Chair will report that this measure has been presented to the committee on appropriations and financial affairs in accordance with the rules.

The resolve then received its first reading, and on motion by Mr. Dodge of Portland, was tabled pending its second reading.

The SPEAKER: The Chair presents for the consideration of the House, Senate Doc. No. 61, Resolve to purchase alphabetical index of Revolutionary pensions in Maine, tabled pending its first reading, and the Chair announces that this measure has been presented to the committee on appropriations and financial affairs in compliance with the rules.

The resolve then received its first reading, and on motion by Mr. Holley of North Anson, was tabled pending its second reading.

On motion by Mr. Luques of Kennebunkport,

Adjourned until tomorrow morning at 10 o'clock.
