Tuesday, February 15, 1921.

Senate called to order by the President pro tempore.

Prayer by Rev. J. P. Irving of Gardiner.

Journal of previous session read and approved.

Papers from House disposed of in concurrence.

House Bill in First Reading

An Act to authorize the American Realty Company to construct and maintain a dam across the St. John river in Township 9, Range 18, W. E. L. S., Somerset County, Maine.

The following bills, petitions, etc., were received and on recommendation of the committee on reference of bills were referred to the following committees:

Claims

By Mr. Holt of Hancock: Resolve in favor of the town of Sorrento, to reimburse the town for expenses of a lawsuit regarding dependents of sailors and soldiers.

Inland Fisheries and Game

By Mr. Cobb of Kennebec: An Act to amend Section 46 of Chapter 33 of the Revised Statutes as amended by Chapter 219 of the laws of Maine of 1917, and Chapter 133 of the laws of Maine of 1919, relating to a close time on muskrats.

Judiciary

Mr. Sprague of Piscataquis: An Act to authorize the county of Piscataquis to enlarge and repair the court house at Dover.

By Mr. Babb of Cumberland: Remonstrance of J. Calvin Miller and 13 others of Portland against the passage of the Barwise Sunday Bill.

By the same senator: Remonstrance of Carlos L. Heel and 11 others of Portland against the passage of the Barwise Sunday bill.

By Mr. Sprague of Piscataquis: Petition of Clara V. Evans and 13

others, members of the Athena Club of Dover-Foxcroft, for the continuance of a Maine Medical School.

Salaries and Fees

By Mr. Baxter of Sagadahoc: An Act to increase the salary of the Judge of Probate of Sagadahoc County.

Ways and Bridges

By Mr. Sargent of Hancock: Resolve in favor of the town of Sedgwick, Hancock county, to aid in rebuilding the Ridge Road, so-called.

By the same senator: Resolve, in favor of the town of Deer Isle, Hancock county, for rebuilding a road and bridge.

By the same senator: Petition of Jay E. Douglass and 30 others of town of Sedgwick in favor of resolve for aid in rebuilding the "Ridge" road in town of Sedgwick.

By the same senator: Petition of Wm. D. Haskell and 24 others of the town of Deer Isle in favor of resolve for aid in building bridge between Deer Isle and Little Deer Isle in town of Deer Isle.

By the same senator: Petition of F. H. Smith and 30 other residents of the town of Sedgwick in favor of resolve for aid to the town of Bluehill in rebuilding road from Sedgwick town line to Bluehill Falls.
