SENATE

Monday, Mar. 7, 1921.

Senate called to order by Hon. Charles E. Gurney, President pro tempore.

Prayer by Rev. J. H. Wilkins of Hallowell.

Journal of previous session read and approved.

Papers from the House disposed of in concurrence.

From the House: An Act additional to Chapter 20 of the Revised Statutes, relating to the sale of poisons.

In the House this bill was referred to the committee on legal affairs.

In the Senate on motion by Mr. Tuttle of Aroostook, tabled and 300 copies ordered printed pending reference in concurrence.

House Bills in First Reading

House 211: An Act to amend Section 56 and paragraph two of Section 57 of Chapter 16 of the Revised Statutes, as amended, relating to the election and term of office of superintendents of schools.

House 212: An Act to amend Section 122 of Chapter 16 of the Revised Statutes as amended by Chapter 143 of the Public Laws of 1919, requiring the teaching of American History and Civil Government in the Public and Private Schools.

House 210: Resolve making an appropriation for co-operative agricultural work between the College of Agriculture of the University of Maine and the United States Department of Agriculture.

House 74: An Act to amend Section 41 of Chapter 51 of the Revised Statutes so as to provide for the amendment of corporate purposes.

House 205: An Act to amend Section 8 of Chapter 118, of the Revised Statutes, relating to fees of jurors.

(Tabled on motion by Mr. Tuttle of Aroostook.)

House 157: An Act to provide for return and cleansing of ice cream and sherbert containers.

(Tabled on motion by Mr. Tuttle of Aroostook.)

House 206: An Act to amend Section 16 of Chapter 28 of the Revised Statutes, increasing the compensation of fenceviewers.

House 207: An Act to amend Section 2 of Chapter 574, Private and Special Laws of 1856, entitled "An Act to incorporate the Kendall's Mills Village Corporation," as amended by Chapter 139, Private and Special Laws of 1891.

House 208: An Act to amend Section 2, Chapter 501, of the Private and Special Laws of 1889, relating to the charter of Maine Central Institute.

House 209: An Act to amend Section 2 of Chapter 51 of the Public Laws of 1919, relating to the training of rural teachers.

To the President of the Senate and the Speaker of the House of Representatives of the Eightieth Legislature.

I have the honor to herewith transmit a copy of the concurrent resolution adopted by the Legislature of the State of South Dakota now in session, requesting co-operation on the part of the several states of the Union in a thorough and practicable investigation as to the cost of crop and live stock productions.

I also have the honor to transmit a reprint of Senate Bill No. 162 of the Legislature of that State, establishing a department of Agriculture, prescribing its powers and duties, etc., and also a copy of the concurrent resolution of the Legislature of that State requesting the Congress of the United States to enact national legislation to provide for governmental review and approval of moving picture films to be used in interstate commerce and showing to the public.

Judiciary

By Mr. Baxter of Sagadahoc: An Act to amend Section 53 of Chapter 64 of the Revised Statutes, as amended by Section 5 of Chapter 297 of the Public Laws of 1917, and as further amended by Section 1 of Chapter 171 of the Public Laws of 1919, relating to the protection of children. (500 ordered printed.)

Bills in First Reading

S. 199: An Act to amend Section 36 of Chapter 104 of the Revised Statutes, relating to admission to bail.

Reports of Committees

Mr. Putnam from the Committee on Interior Waters, on An Act authorizing the Orono Pulp and Paper Company to erect and maintain booms and piers at the inlet of Saponic Lake and at Short Carry above the inlet of said Lake, reported the same in a new draft under the title of "An Act authorizing the Orono Pulp and Paper Company to erect and maintain booms and piers at and near Bunker Landing on the Passadumkeag River, all in the County of Penobscot," and that it ought to pass.

Mr. Thompson from the Committee on Legal Affairs, on An Act to amend Chapter 134 of the Public Laws of 1834, as amended by Chapter 167 of the Public Laws of 1835, as amended by Section 11 of the City Charter of the City of Bath, as amended by Chapter 135 of the Public Laws of 1895, relating to a Municipal Court in the City of Bath, reported that the same ought to pass.

Mr. Thombs from the Committee on Legal Affairs on An Act to amend

Section 98 of Chapter 82 of the Revised Statutes, relating to the exchange of Justices of Superior Court (Senate Doc. No. 30), reported that the same ought to pass.

The reports were accepted and the bills tabled for printing under the joint rules.

Mr. Thombs from the Committee on Legal Affairs on An Act authorizing and requiring the Passadumkeag Log Driving Company to erect and maintain Piers, Booms and a Sorting Gap at the inlet of Saponic Lake and at Short Carry above the inlet of said Lake, reported that the same ought not to pass.

The same senator from the same committee, on An Act to amend the charter of the Northern Cumberland Municipal Court, reported that the same be referred to the Committee on Salaries and Fees.

The reports were accepted and sent down for concurrence.

Passed to Be Engrossed

S. 96. An Act to confer additional rights and powers upon Penobscot Lumbering Association, a corporation incorporated by Special Act of the Legislature approved April 5, 1854.

S. 97. An Act to amend Section 18 of Chapter 130 of the Revised Statutes in relation to the disposal of fines imposed thereunder and personal property used for prizes in lotteries or devices of chance and the procedure of punishment.

H. 200. An Act to amend Section 55 of Chapter 33 of the Revised Statutes as amended by Chapter 219 and Chapter 244 of the Public Laws of 1917 and by Chapter 62 of the Public Laws of 1919, relating to the protection of game birds.

H. 196. An Act to protect the water supply of the town of East Livermore.

H. 195. An Act to amend Section 1 of Chapter 66 of the Public Laws of 1917, as amended by Chapter 244 of the Public Laws of 1917, relating to non-resident fishing license fees.

H. 194. An Act to authorize the town of Rangeley to acquire the

wharves in Rangeley Lake of the Rangeley Lake Steamboat Company.

H. 197. An Act to authorize the town of Cape Elizabeth to adopt a corporate seal.

H. 202. An Act to incorporate the Monmouth water and sewer district.

H. 193. An Act to confirm and make valid the municipal election held in the city of Eastport, on the first Monday of March, 1920.

H. 198. Resolve to reimburse the town of Mapleton. (Tabled on motion by Mr. Baxter of Sagadahoc, pending second reading.)

H. 204. Resolve in favor of the town of Hartland for aid rendered to a mother with dependent children during the year 1918, under the provisions of Chapter 222 of the Public Laws of 1917.
