Monday, March 14, 1921.

Senate called to order by Hon. Charles E. Gurney, President protempore at 4.30 o'clock.

Prayer by Rev. F. A. Foxcroft of Hallowell.

Journal of previous session read and approved.

Papers from the House disposed of in concurrence.

House 251: An Act to amend Chapter 218 of the Public Laws of 1917, providing for the establishment of a Bureau of Markets.

House 252: An Act to amend Section 11 of Chapter 46 of the Revised Statutes, as amended by Chapter 74 of the Public Laws of 1919, relating to the furnishing of slips by weighters.

House 253: An Act to amend the charter of the Mutual Fire Insurance Company of Saco, Maine.

House 254: An Act to authorize the town of Sanford to raise and expend money to erect a memorial to its soldiers and sailors.

An Act to amend Section 67 of Chapter 142 of the Revised Statutes, relating to inmates escaping from the Reformatory for Women. (Signed March 10.)

An Act to amend Sub-paragraph (a) of Paragraph II of Section 59 of Chapter 16 of the Revised Statutes, as enacted and set forth by Section 7 of Chapter 188 of the Public Laws of 1917, relating to the duties of superintendents of schools. (Signed March 10.)

An Act relating to protection of deer in the town of York, in the county of York. (Signed March 10.)

An Act to Amend Section 2 of Chapter 50 of the Public Laws of 1917 relating to warning signs at grade crossings. (Signed March 10.)

An Act to amend Section 72 of Chapter 56 of the Revised Statutes, relating to the ringing of the engine bell or sounding of the whistle at grade crossings. (Signed March 10.)

An Act to Amend Sections 3, 4, 12 and 13 of Chapter 145 of the Public Laws of 1917, relating to the removal of obstructions at grade crossings. (Signed March 10.)

An Act to amend Section 76 of Chapter 82 of the Revised Statutes, as amended by Chapter 280 of the Public Laws of 1917 and by Chapter 192 of the Public Laws of 1919 relative to price of Maine Reports. (Signed March 10.)

An Act requiring political advertisements to be signed. (Signed March 10.)

An Act to amend Section 10 of Chapter 182 of the Public Laws of 1919, relating to inmates escaping from the Reformatory for Men. (Signed March 10.)

An Act additional to Chapter 33 of the Revised Statutes, as amended, prohibiting hunting in certain territory in the town of Fairfield, in the county of Somerset. (Signed March 10.)

Education

By Mr. Thombs of Penobscot: An Act to amend Section 2, Chapter 16 of the Revised Statutes to provide for the improvement of conveyance of pupils to common schools.

Judiciary

Mr. Eaton of Oxford: An Act to define exemptions in disclosure process.

Legal Affairs

Mr. Garcelon of Androscoggin: An Act to amend Section 22 of Chapter 51 of the Revised Statutes, relating to records and stock-books of corporations.

Orders

On motion by Mr. Allen of York,

Ordered, that the Governor be requested to return bill entitled "An Act to amend Section 14 of Chapter 16 of the Revised Statutes, as amended by Chapter 62 of the Public Laws of 1917, relating to the provisions for heating, lighting, ventilating and hygienic conditions in new or reconstructed school buildings."

Mr. ALLEN: Mr. President, if the bill is in the hands of the Secretary, I move that it lie on the table.

The motion was agreed to.

Mr. PUTNAM of Washington: Mr. President, I move to suspend the rules and reconsider the vote whereby we passed to be enacted House Document 200, relating to protection of game birds.

The motion was agreed to, and on further motion by the same Senator, the bill was tabled.

S. 112: Resolve reimbursing the St. Mary's General Hospital of Lewiston for services rendered in the care of certain patients during the calendar year 1919.

S. 113: An Act to amend Section 43 of Chapter 2 of the Revised Statutes relating to the appointment of dedimus justices.

S. 114: Resolve to reimburse the town of Rumford.

Reports of Committees

Mr. Gillin from the Committee on Judiciary, on An Act to amend Chapter 145, Section 30 of the Revised Statutes, relating to the duties of the hospital trustees, reported that the same ought not to pass.

The report was accepted and sent down for concurrence.

Mr. Parent from the same Committee, on An Act to amend the charter of the City of Lewiston relating to the office of City Clerk (Senate Doc. No. 55), reported that the same ought to pass.

The same Senator from the same Committee, on An Act to amend Chapter 37 of the Private and Special Laws of 1917, entitled "An Act to provide a police commission for the City of Lewiston, to promote the efficiency of the police department thereof, as amended," reported that the same ought to pass.

The same Senator from the same Committee, on An Act to abolish the Board of Public Works of the City of Lewiston and to provide for a Highway Commission (Senate Doc. No. 72), reported the same in a new draft under the same title, and that it ought to pass.

The same Senator from the same Committee, on An Act to promote the efficiency of the Fire Department of the City of Lewiston (Senate Doc. No. 60), reported the same in a new draft under the same title, and that it ought to pass.

The same Senator from the same Committee, on An Act to amend the charter of the City of Lewiston and to provide for a city auditor (Senate Doc. No. 56), reported the same in a new draft under the same title, and that it ought to pass.

Mr. Emerson from the committee on State Lands and Forest Preservation, on An Act to amend Section 53 of Chapter 8 of the Revised Statutes, as amended by Chapter 111 of the Public Laws of 1919, requiring a permit for

the burning of brush or slash near woodlands (Senate Doc. No. 46), reported the same in a new draft under the same title, and that it ought to pass.

The same senator from the same committee, on An Act to amend Chapter 8 of the Revised Statutes, as amended by Chapters 111 and 168 of the Public Laws of 1919, requiring a permit for the burning of blueberry land adjacent to forest growth, reported that the same ought to pass.

Mr. Thompson from the committee on Temperance, on An Act to amend Chapter 127 of the Revised Statutes, prohibiting the manufacture of intoxicating liquors, so that said Chapter will be in harmony with the federal law, reported that the same ought to pass.

The same senator from the same committee, on An Act to amend Chapter 294 of the Laws of 1917, relating to seizure and forfeiture of vehicles carrying intoxicating liquors intended for illegal sale, reported that the same ought to pass.

Mr. Eaton from the committee on Towns, on An Act to repeal the act incorporating the town of Hurricane Isle, reported that the same ought to pass.

The reports were accepted and the bills tabled for printing under the joint rules.
