#### SENATE

Saturday, April 2, 1921.

Senate called to order by Hon. Charles E. Gurney, President pro tempore, at 8.30 o'clock.

Prayer by Rev. C. O. Perry of Gardiner.

Journal of previous session read and approved.

Papers from the House disposed of in concurrence.

From the House: An Act to amend Section 21 of Chapter 176 of the Revised Statutes, increasing the salary of the commissioner of agriculture.

In the House, House Amendment A was adopted.

(The amendment was read by the Chair.)

Mr. SPRAGUE of Piscataquis: Mr. President, I know so little about this. I am in favor of carrying out at least what the committee agreed upon for this department. I do not desire to read it, but I move it lie on the table.

Mr. PARENT of Androscoggin: Mr. President, I rise for an inquiry. What is the nature of the amendment as compared with the bill as reported by the committee?

The PRESIDENT: It merely strikes out the provisions that appear in the present statute relative to the live stock sanitary commissioner, whose office the Chair understands has been abolished.

The motion to table was adopted.

Mr. THOMES of Penobscot: Mr. President, inasmuch as I have to leave the chamber within a few minutes, I desire to mave that the rules be suspended that I may introduce an amendment out of order.

The motion was agreed to.

On further motion by the same senator the workmen's compensation bill was taken from the table. (H. D. 400.)

Mr. THOMBS: Mr. President and fellow senators, it has been found upon a careful perusal of the bill as amended that there was an error made in copying. The error perhaps does not relate to a proposed change of any law, but in copying a certain section of the old law the word "and" was used where "or" appears in the law. The amendment is offered for the sole purpose of correcting that error.

The pending question being the adoption of the report of the committee on bills in second reading, the same was adopted.

Mr. Thombs then offered Senate Amendment A which was adopted. The bill as amended was given its second reading and was passed to be engrossed.

From the House: An Act to regulate the use of motor driven vehicles on highways.

In the House, Senate Amendment A was rejected, and House Amendment A adopted.

On motion by Mr. Gillin of Penobscot the bill was tabled.

From the House: An Act to make uniform the fees of deputy sheriffs in attendance upon the supreme judicial courts.

In the House, House Amendment A was adopted.

On motion by Mr. Babb of Cumberland, the Senate voted to non-concur in the adoption of House Amendment  $\Lambda$ , and insist upon its former action.

Sent down for concurrence.

From the House: The majority report of the committee on judiciary, ought to pass in new draft, on An Act to amend Chapter 51 of the Revised Statutes, as amended by Chapter 144 of the Public Laws of 1917, relating to the formation of corporations having stock without par value.

(On motion by Mr. Gillin, under suspension of the rules read twice and passed to be engrossed.)

#### Orders of the Day

The PRESIDENT: Under orders of the day, the Chair will lay before the Senate, agreeably to the rule, the unfinished business of yesterday at the time of adjournment.

The Chair lays before the Senate, An Act relating to salaries of clerks of courts, tabled by the Senator from Piscataquis, Senator Sprague.

Mr. SPRAGUE of Piscataquis: Mr. President, I am not entirely familiar with just what that bill is, and intended to investigate and have not had time.

The PRESIDENT: The Chair will say that the bill has not been printed.

Mr. SPRAGUE: What I want to know, what the gist of it is. Does it raise the salaries?

The PRESIDENT: Of the various clerks of courts of the various counties. Would the Senator like to have it read?

Mr. SPRAGUE: Now I think it is not necessary to pass it, but Mr. Folsom, the chairman of the committee is away—is the report, ought not to pass? LEGISLATIVE RECORD-SENATE, APRIL 2, 1921

The PRESIDENT: Yes, the report is ought not to pass.

Mr. SPRAGUE: Then I move to accept the report. I think matters I am interested in are taken care of in another way.

The motion was agreed to.

The PRESIDENT: The Chair lays before the Senate, S. D. 61, Resolve in favor of purchasing index of Revclutionary pensioners in Maine, tabled by the Senator from Piscataquis, Senator Sprague, the pending question being reconsideration of passage to be enacted.

Mr. SPRAGUE of Piscataquis: Mr. President, I am glad to inform the Senate that now I am positive that there is no objection to this resolve. It is a small matter, only \$300, and a very important document.

The PRESIDENT: The question before the Senate is whether or not the Senate shall reconsider its action by which this was passed to be enacted.

A viva voce vote was had and the motion to reconsider was lost.

Mr. GILLIN of . Penobscot: Mr. President, my sole purpose in voting "no" and objecting, I wish to call the attention of the distinguished Senator from Piscataquis, is simply on account of the number of Senators who are now present. I have no objection.

Mr. SPRAGUE: Mr. President, I will say that I will guarantee that every Senator that has been opposed to it in any form is satisfied with it.

The PRESIDENT: The Chair lays before the Senate H. D. 242, Resolve in favor of Northern Oxford Fish and Game Association, tabled by the Senator from Piscataquis, Senator Sprague, the pending question being the adoption of Senate Amendment "A."

Mr. SPRAGUE: Mr. President, Senator Eaton is in favor of that. The situation is this: If Senate Amendment A should be adopted, I suppose that I should be for indefinitely postponing the bill, because it would have to come out of a fund that is already pared down more than it ought to be in the fish and game department. But by request of Senator Eaton, who was obliged to go away and take this train, I move that it lie upon the table.

The PRESIDENT: Will the senator assign a date for it?

Mr. SPRAGUE: Tuesday.

The motion was agreed to and the matter was tabled and specially assigned for Tuesday of next week.

The PRESIDENT: The Chair lays before the Senate S. D. 137, An Act relative to sawdust and mill waste, the pending question being the reconsideration of the passage to be engrossed.

Mr. CLEMENT of Waldo: Mr. President, I move it be indefinitely postponed.

Mr. SPRAGUE of Piscataquis: I second the motion.

Mr. Gillin of Penobscot: To what river does that apply?

The PRESIDENT: Can the senator from Waldo answer the question of the senator from Penobscot?

Mr. CLEMENT: Medomak stream, in Liberty.

Mr. GILLIN: I asked the question, Mr. President, so that I could vote intelligently. Thank you, senator.

Mr. SPRAGUE: I will say, Mr. President, in reply to the senator from PenoDScot, as I understand it, whoever drew it did it wrong. It includes a lot of lakes and ponds and streams that have already been closed for years, and so the only way out of this is to indefinitely postpone.

The motion was agreed to by a viva voce vote.

The PRESIDENT: The Chair lays before the Senate H. D. 231, An Act relating to the placing of bear traps, tabled by the senator from Lincoln, Senator Clark, the pending question being the passage to be enacted.

On motion by Mr. Clark of Lincoln, the bill was passed to be enacted.

The PRESIDENT: The Chair lays before the Senate An Act relating to ballots in primary elections, tabled

by the senator from Kennebec, Senator Farrington, and assigned for today.

Mr. FARRINGTON of Kennebec: Mr. President, this is a very important bill and I move that it be laid on the table and especially assigned for Tuesday.

The motion was agreed to.

Mr. SPRAGUE of Piscataquis: Mr. President, I move to recall from the Executive the Resolves in favor of purchasing the History of Grand Lake Stream Plantation and the History of the Town of Williamsburg, each to be laid upon the table temporarily.

The PRESIDENT: The Chair will state to the senator from Piscataquis, Senator Sprague, that the bills are not available at this time but the order having had a passage they will doubtless be obtained by Monday next.

Mr. FARRINGTON of Kennebcc: Mr. President, I move to take from the table Resolve in favor of the Emery-Waterhouse Company of Portland, the pending question according to the calendar being acceptance of the report.

The motion was agreed to, and on further motion by the same senator the report of the committee was accepted, and the resolve was tabled for printing.

Mr. EMERY of Washington: Mr. President, at the request of Senator Morison, I move to take from the table, Resolve to fix salary of representatives to the Legislature of the Indian tribes.

The motion was agreed to, and on further motion by the same senator the report of the committee "ought to pass" was accepted, and on further motion by the same senator the matter was indefinitely postponed in concurrence with the House.

On motion by Mr. Emerson of Aroostook,

Adjourned until Monday morning at ten o'clock.
